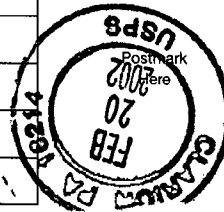


COMPLAINT

1. Plaintiff, BRUCE R. SIMONS, is an adult residing at 815 Hill St., Ridgway, PA 15853.
2. Defendant, CLEARFIELD JEFFERSON CMHC and GATEWAY INSTITUTE & CLINIC, INC., are Pennsylvania institutions having an office at 100 Caldwell Drive, DuBois, PA 15801.
3. Plaintiff, Bruce R. Simons, was employed as a psychologist for defendant, Gateway Institute & Clinic, Inc. beginning July 1, 1997 and ending November 16, 2001.
4. While an employee of Gateway Institute & Clinic, Inc., plaintiff accrued vacation time in the amount of 211.69 hours; all as shown on plaintiff's pay stub, dated November 21, 2001 and attached hereto as plaintiff's Exhibit 'A'.
5. Upon the plaintiffs leaving the employ of defendant, defendant refused and has continued to refuse payment for defendant's accrued vacation time.
6. While in the employ of defendant, plaintiff's base rate of pay was \$38.50 per hour.

7. Plaintiff, having accrued vacation time of 211.69 hours at his pay rate of \$38.50 per hour, has demanded of defendant payment in the amount of \$8,150.07, less deductions for appropriate taxes; which demand for payment defendant has refused.

WHEREFORE, plaintiff demands judgment of defendant in the amount of \$8,150.07, less appropriate taxes, plus interest, costs of suit and reasonable attorney's fees along with such other remedies as the Arbitration Board may direct.
