Russell & Donald R. Russell (Deed Book 437, Page 565, dated November 30, 1976), said P.K. nail also being the northeast corner of the herein described parcel and further being referenced as Corner Number 3 on survey map; thence S 00 Degrees 18 Minutes W along the centerline of S.R. 4015 (33-foot R/W) and along the lands now or formerly Angelo J. Ferraraccio & Jeanne M. Johnson (Deed Book 1270, Page 132, dated February 16, 1989) a distance of 348.88 feet to a P.K. nail set in said centerline of S.R. 4015, said P.K. nail being southeast corner of the herein described parcel and further being referenced as Corner Number 4 on survey map; thence N 85 Degrees 33 Minutes W through the western right-of-way for S.R. 4015 (33-foot R/W) and also through the lands now or formerly Steven M. Petrini (Deed Book 1942, Page 548, dated March 26, 1998) a distance of 561.47 feet to a one-inch iron pipe set by this survey, said iron pipe being the southwest corner of the herein described parcel and further being referenced as Corner Number 9 on survey map; thence N 00 Degrees 18 Minutes E through the lands now or formerly Steven M. Petrini (Deed Book 1942, Page 548, dated March 26, 1998) a distance of 247.69 feet to a one-inch iron pipe set by this survey, said iron pipe being referenced as Corner Number 10 on survey map; thence N 85 Degrees 39 Minutes W through the lands now or formerly Steven M. Petrini (Deed Book 1942, Page 548, dated March 26, 1998) a distance of 80.20 feet to a one-inch iron pipe set by survey, said iron pipe being referenced as Corner Number 11 on survey map; thence N 00 Degrees 18 Minutes E through the lands now or formerly Steven M. Petrini (Deed Book 1942, Page 548, dated March 26, 1998) a distance of 100.25 feet to a one inch iron pipe set by survey, said iron pipe being the northwest corner of the herein described parcel and further being referenced as Corner Number 12 on the herein described parcel; thence S 85 Degrees 39 Minutes E through the lands now or formerly Steven M. Petrini (Deed Book 1942, Page 548, dated March 26, 1998) and through the western right-of-way for S.R. 4015 (33-foot R/W) a distance of 641.60 feet to a P.K. Nail set in the centerline of said S.R. 4015, said P.K. Nail being the northeast corner of the herein described parcel and further being referenced as Corner Number 3 on survey map, the place of beginning. CONTAINING 203.128.8 square feet or 4.66 acres.


