The Plaintiff, GREGORY N. DIXON, SR., through his attorney, WARREN B. MIKESELL, II, complains upon a cause of action whereof the following is a statement.

1. That the Plaintiff is an adult individual, residing at RD Box 602, Morrisdale, Pennsylvania, 16858.

2. That the Defendant, JOHN C. DIXON, is believed to be the individual who went by the name of CHARLES DIXON. The said CHARLES DIXON and ELSIE SMEAL, his wife, were believed to have had the following heirs at law:

3. That by Deed dated September 1, 1937, JAMES H. DIXON, conveyed three (3) acres of land situate in Boggs Township, Clearfield County, Pennsylvania to JOHN C. DIXON, with said Deed being recorded in The Office of the Recorder of Deeds of Clearfield County, Pennsylvania, in Deed Book 320, page 132.

4. That the aforesaid three (3) acres of land situate in Boggs Township, Clearfield County, Pennsylvania which was conveyed to JOHN C. DIXON from JAMES H. DIXON was assessed in the name of CHARLES DIXON in the Clearfield County Assessment Office in 1943.

5. That the aforesaid three (3) acre parcel of land situate in Boggs Township, Clearfield County, Pennsylvania was assessed in the name of CHARLES DIXON was sold to Clearfield County for non-payment of real estate taxes in 1943.

6. That the Deed for the Clearfield County Treasurer to the Clearfield County Commissioners was never recorded of record in Clearfield County, Pennsylvania.

7. That Hannah Waple, widow, purchased the aforesaid three (3) acre parcel of situate in Boggs Township, Clearfield County, Pennsylvania from Clearfield County, Pennsylvania in 1945.

8. That the Deed from the Clearfield County Commissioners to HANNAH WAPLE, widow, was never recorded of record in Clearfield County, Pennsylvania.

9. That HANNAH WAPLE, widow, conveyed the three (3) acres of land situate in Boggs Township, Clearfield County, Pennsylvania to GRANT LUMADUE and ARLENE LUMADUE, his wife, by Deed dated February 27, 1946, as recorded in The Office of the Recorder of Deeds of Clearfield County, Pennsylvania in Deed Book 378, page 30.

10. That the said GRANT LUMADUE and ARLEN LUMADUE, his wife, conveyed the said three (3) acres of land situate in Boggs Township, Clearfield County, Pennsylvania by Deed dated May 23, 1947, to EDWARD DIXON and MARTHA DIXON, husband and wife as tenants by the entireties, as recorded in the Office of the Recorder of Deeds of Clearfield County, Pennsylvania, in Deed Book 384, page 243.

11. That the said EDWARD DIXON died on February 6, 2001. A copy of his Death Certificate is recorded in the Office of the Recorder of Deeds of Clearfield County, Pennsylvania, as an attachment to the Deed recorded as Instrument Number 200111676.

12. That the said MARTHA DIXON did execute a Durable General Power of Attorney appointing her daughters HOPE R. GRAHAM and TRUDY K. TARACHKO, as attorneys-in-fact and did cause the said Power of Attorney to be recorded in the Office of the Recorder of Deeds of Clearfield County, Pennsylvania in Deed and Record Book 1937, page 417.

13. That the said MARTHA DIXON, by and through her Attorneys in Fact did convey the said three (3) acres of land situate in Boggs Township, Clearfield County, Pennsylvania by Deed dated July 27, 2001, to GREGORY N. DIXON, SR., as recorded in the Office of the Recorder of Deeds of Clearfield County, Pennsylvania as Instrument Number 200111676.

14. That the said Plaintiff, GREGORY N. DIXON, SR., is the owner of the premises situate in Boggs Township, Clearfield County, Pennsylvania, and more particularly described as follows:

ALL that certain tract of land situate in the Township of Boggs, County of Clearfield and State of Pennsylvania, bounded and described as follows:

BEING the three (3) acres formerly assessed to Charles Dixon in Boggs Township, Clearfield County, and the premises which were returned by the Collector of taxes for non-payment of taxes for the year 1940 and were sold at public vendue by Edna Marsden, Treasurer of Clearfield County, on the 22nd day of January, 1943, to Clearfield County. The said premises were sold by the County Commissioners by Public vendue on the 26th day of March, 1945, to Hannah Waple, their deed being dated the 9th day of July 1945. And the said Hannah Waple, widow, by deed dated the 27th day of February, 1946 recorded at Clearfield in Deed Book No. 378, page 30, granted and conveyed the same to Grant Lumadue and Arlene Lumadue. The said Grant Lumadue and Arlene Lumadue having conveyed the said premises to Edward Dixon and Martha Dixon, by Deed dated May 23, 1947, and recorded in The Office of the Recorder of Deeds of Clearfield County, Pennsylvania, in Deed Book 384, page 243. The said Martha Dixon having conveyed the said three (3) acres to Gregory N. Dixon, Sr., by Deed dated July 27, 2001, as recorded in the Office of Recorder of Deeds of Clearfield County, Pennsylvania, as Instrument Number 200111676, the present.

The said premises are further described in a Deed from James H. Dixon to John C. Dixon, dated September 1, 1937, as recorded at Clearfield in Deed Book No. 320, page 132:

BEGINNING at a post and corner on Township road and land of J. H. Dixon running North along land of J. H. Dixon thirty seven (37) rods to a post and corner on land of J. H. Dixon. Thence running along said land West thirteen (13) rod to a post and corner on land of J. H. Dixon thence along land of J. H. Dixon thirty seven (37) rod South to a post and corner on land of J. H. Dixon and Township road. Thence along land of J. H. Dixon and Township road East thirteen (13) rod to a post and corner and place of beginning Containing three (3) acres net.

Being the same parcel listed as Clearfield County Map Number 105-010-06

15. That the Plaintiff avers it is the purpose and intention of this Action to Quiet Title to extinguish any and all

of the Defendants' interest as a result of any improprieties in the assessment or sale of the herein described property for the nonpayment of real estates taxes of the subject premises.

16. That the Plaintiff and his predecessors in title to the above described properties listed in Paragraph 14 herein have exercised dominion, possession and control of the subject premises for a period in excess of twenty-one (21) years to wit: The Plaintiff's predecessors in title have utilized the property as their principle residence and further, the Plaintiff and his predecessors in title since 1947 have exclusively utilized the entire three (3) acres as a residence and have planted trees and shrubbery etc., have built, repaired and maintained the buildings and structures on the said property, all being adverse, continuous, open, visible, notorious, exclusive and hostile possession of the property.

17. That it is believed and therefore averred that the said Defendants were fully apprized of the tax sale effecting their interest in the said real estate as hereinbefore described, had due notice thereof, through advertisement in a newspaper of general circulation, through posting of the said premises, by actual notice as provided by registered mail, and that the said Defendants named herein failed and neglected to take any action in order to protect their respective interests in the said premises, they being fully apprized of the same and fully knowledgeable as to the sale of said premises to your Plaintiff herein or his predecessors in title.

18. That at no time have any of the herein named Defendants, their heirs, executors, administrators, successors and assigns, attempted to secure possession of the said real estate subject to this action, contest the title of the Plaintiff and/or his predecessors in title or assert any interest adverse to that of Plaintiff or his predecessors in title by any legal action or by formal acknowledgment thereof.

19. That the premises herein described in Paragraph 14 is the same premises that Plaintiff and his predecessors in title have been in adverse, open, exclusive, continuous, notorious, hostile and uninterrupted possession for a period in excess of twenty-one (21) years, possession of the said premises having been acquired by the Plaintiff and his predecessors in title as herein above set forth.

20. That the said Plaintiff and/or his predecessors in title have, commencing with the year 1947, and continuing up to the present time, made valuable improvements to the said premises, maintained the same premises, paid all current real estate taxes, and evidenced a settled intent of excluding all individuals, including but not limited to the Defendants, their heirs, executors, administrators, successors and assigns, from the use, actual occupation or constructive possession of the subject premises.

21. That at no time have any of the herein named Defendants attempted to secure possession of the said premises, contest the title of the Plaintiff or his predecessors in title, or assist in the maintenance, repair or improvements or those premises hereinbefore described nor has any asserted any interest adverse to the Plaintiff or his predecessors in title by legal action.

WHEREFORE, the Plaintiff respectfully request:


a) That the Defendant, their successors and assigns and any other person claiming under them, and all other persons having a claim to the premises described herein, be ordered to bring an action of ejectment to establish their claim to the premises described herein, within a time set by the Court, or be forever barred from setting up any title to the said premises and the use of the same, and from impeaching, denying or in any way attacking Plaintiff's title to said premises, from encumbering, mortgaging or conveying this parcel or any part thereof, or from asserting in any manner, any right, lien, title or interest inconsistent with the interest or claims of the Plaintiff as set forth in his Complaint.

b) That the Court declare the Plaintiff to be the sole owner and to be entitled to the exclusive possession of the premises described herein in Paragraph 14 by virtue of his adverse, open, notorious, exclusive, uninterrupted and hostile possession of the premises for a period in excess of twenty-one (21) years.

c) That an Order be made setting aside any defect which may have resulted from lack of notice of the said tax claim, and/or tax sale, or any other defect or irregularity occurring in the proceedings leading up to and resulting in the tax sale

wherein the Plaintiff and his predecessors in title secured title, and further confirming all actions of the tax office with respect to the notice requirements and further confirming all other actions undertaken by the tax office preparatory to or in consummation of the subsequent sale, all of which is as provided under the applicable sections of the Pennsylvania Real Estate Tax Sale Law.


d) That the Court make such further orders as may be necessary to establish the title of the Plaintiff and to grant him appropriate relief.



DIXON, SR., as recorded in the Office of the Recorder of Deeds of Clearfield County, Pennsylvania as Instrument Number 2001111676.

14. That the said Plaintiff, GREGORY N. DIXON, SR., is the owner of the premises situate in Boggs Township, Clearfield County, Pennsylvania, and more particularly described as follows:

ALL that certain tract of land situate in the Township of Boggs, County of Clearfield and State of Pennsylvania, bounded and described as follows:

DIXON KORB and HAROLD I. KORB, her husband; SYLVIA JEAN DIXON-GALENTINE and THOMAS R. GALENTINE, her husband; ANNA MAE ZIEGLER and WILLIAM A. ZIEGLER, Jr.; her husband; SARA E. ZEIGLER (note: her husband, HOWARD R. was unable to execute a Deed due to illness); SHIRLEY M. BOCK; MARY LOU HARMON and JAMES W. HARMON, her husband; BARBARA KOPP and GERALD KOPP, her husband; WANITA NIXON and VERNON NIXON, her husband; DEBRA J. WILT; NORMA JEAN CUMMINGS and GLENN E. CUMMINGS, her husband; FREDA DIXON; JAMES M. DIXON; RICHARD A. DIXON; and HAROLD L. DIXON and MARY LOU DIXON, his wife.

16. That an attempt to contact all of the heirs at law of JOHN C. DIXON, a/k/a CHARLES DIXON, was made by first class mail to the last known address of all of the original named Defendants and the following listed Defendant's mailings were returned as undeliverable with no forwarding address:

DONNIE DIXON, CHARLES DIXON, LEWIS MAINES, and LINDA KIRK

17. That the Plaintiff avers it is the purpose and intention of this Action to Quiet Title to extinguish any and all of the Defendants' interest as a result of any improprieties in the assessment or sale of the herein described property for the nonpayment of real estates taxes of the subject premises.

18. That the Plaintiff and his predecessors in title to the above described properties listed in Paragraph 14 herein have exercised dominion, possession and control of the subject premises for a period in excess of twenty-one (21) years to wit: The Plaintiff's predecessors in title have utilized the property as their principle residence and further, the Plaintiff and his predecessors in title since 1947 have exclusively utilized the entire three (3) acres as a residence and have planted trees and shrubbery etc., have built, repaired and maintained the buildings and structures on the said property, all being adverse, continuous, open, visible, notorious, exclusive and hostile possession of the property.

19. That it is believed and therefore averred that the said Defendants were fully apprized of the tax sale effecting their interest in the said real estate as hereinbefore described, had due notice thereof, through advertisement in a newspaper of general circulation, through posting of the said premises, by actual notice as provided by registered mail, and that the said Defendants named herein failed and neglected to take any action in order to protect their respective interests in the said premises, they being fully apprized of the same and fully knowledgeable as to the sale of said premises to your Plaintiff herein or his predecessors in title.

20. That at no time have any of the herein named Defendants, their heirs, executors, administrators, successors and assigns, attempted to secure possession of the said real estate subject to this action, contest the title of the Plaintiff and/or his predecessors in title or assert any interest adverse to that of Plaintiff or his predecessors in title by any legal action or by formal acknowledgment thereof.

21. That the premises herein described in Paragraph 14 is the same premises that Plaintiff and his predecessors in title have been in adverse, open, exclusive, continuous, notorious, hostile and uninterrupted possession for a period in excess of twenty-one (21) years, possession of the said premises having been acquired by the Plaintiff and his predecessors in title as herein above set forth.

22. That the said Plaintiff and/or his predecessors in title have, commencing with the year 1947, and continuing up to the present time, made valuable improvements to the said premises, maintained the same premises, paid all current real estate taxes, and evidenced a settled intent of excluding all individuals, including but not limited to the Defendants, their heirs, executors, administrators, successors and assigns, from the use, actual occupation or constructive possession of the subject premises.

23. That at no time have any of the herein named Defendants attempted to secure possession of the said premises, contest the title of the Plaintiff or his predecessors in title, or assist in the maintenance, repair or improvements or those premises hereinbefore described nor has any asserted any interest adverse to the Plaintiff or his predecessors in title by legal action.


WHEREFORE, the Plaintiff respectfully request:

c) That an Order be made setting aside any defect which may have resulted from lack of notice of the said tax claim, and/or tax sale, or any other defect or irregularity occurring in the proceedings leading up to and resulting in the tax sale wherein the Plaintiff and his predecessors in title secured title, and further confirming all actions of the tax office with respect to the notice requirements and further confirming all other actions undertaken by the tax office preparatory to or in consummation of the subsequent sale, all of which is as provided under the applicable sections of the Pennsylvania Real Estate Tax Sale Law.

d) That the Court make such further orders as may be necessary to establish the title of the Plaintiff and to grant him appropriate relief.
