10. Petitioner is not requesting a change of her name to avoid any creditors.



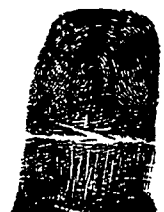
