

WHEREAS, LEZZER CASH & CARRY OF CURWENSVILLE, INC., a Pennsylvania corporation ("Lezzzer"), entered a judgment against William C. McCracken and Donna M. McCracken, t/d/b/a B & C Home Improvements, in the principal amount of \$1,961.59 on March 12, 2002, filed in the Office of the Prothonotary of Clearfield County, Pennsylvania, to No. 02-368-CD, placing a lien of judgment on premises situate at 213 W. COMPLAINT

Plaintiff files this Complaint pursuant to Pa. R.C.P.  
No. 2951(b) for judgment by confession and avers the following:

1. Plaintiff, LEZZER CASH & CARRY of CURWENSVILLE, INC., is a corporation, organized and existing under the laws of the Commonwealth of Pennsylvania, which has its main office at Scofield Street, P. O. Box 217, Curwensville, Pennsylvania, 16833.

2. Defendants, WILLIAM C. McCRACKEN and DONNA M. McCRACKEN, husband and wife, are adult individuals residing at R. R. #1, Box 327, West Decatur (Clearfield County), Pennsylvania 16878.

3. Defendants are engaged in a business under the trade name of B & C Home Improvements which maintains the same mailing address as the Defendants and which is set forth at length in Paragraph 2 hereof.

4. Plaintiff is engaged in the business of selling and furnishing materials and building supplies to entities involved in the construction and/or home improvement business.

5. Attached as Exhibit "A" is a true and correct copy of an Application for Credit, containing a Credit Account Agreement, dated August 26, 1996, between Plaintiff, Lezzer Cash & Carry of Curwensville, Inc. and Defendants, William C. McCracken and Donna M. McCracken, t/d/b/a B & C Home Improvements which credit application was accepted by Plaintiff at a credit line of \$5,000.00 by virtue of Plaintiff's letter of August 27, 1996, addressed to B & C Home Improvements, which is also attached hereto and made a part hereof as Exhibit "B".

6. The judgment to be entered hereunder by confession is not being entered against the Defendants, William C. McCracken and Donna M. McCracken, t/d/b/a B & C Home Improvements, in connection with a consumer credit transaction, nor does the same arise out of a retail installment sale, contract or account subject to the provisions of the Goods and Services Installment Sale Act, as amended. (See 69 P.S. §1101 et seq).

7. Defendants' Credit Account Agreement referred to in Paragraph 5 hereof has not been assigned by Plaintiff.

8. No judgment has been entered against the named Defendants in any court of record pursuant to the warrant of attorney provisions set forth in the aforementioned Credit Account Agreement as referenced in Paragraph 5 hereof.

9. Defendants, William C. McCracken and Donna M. McCracken, t/d/b/a B & C Home Improvements, are in default

under the terms of the aforementioned Credit Account Agreement since they have not paid for the building materials and supplies purchased on credit from Plaintiff on October 11, 2001, October 15, 2001, October 23, 2001, October 24, 2001, October 25, 2001 and November 20, 2001 despite being billed for said items.


