**COMPLAINT IN CIVIL ACTION**

Plaintiffs, Harry Jefferson Ripley, Jr. and Evelyn Ripley, his wife, by their attorneys, Jerome W. Kiger, Esquire, Amy B. Kubisiak, Esquire and Kiger & Alpern, Esquires make the following Complaint against the Defendant:

1. Plaintiff, Harry Jefferson Ripley, Jr. and Evelyn Ripley, his wife, are adult individual residing at 35 Cardinal Drive, DuBois, Clearfield County, Pennsylvania 15801.
2. Defendant, Matthew T. Belin is an adult individual residing at 300 Treasure Lake, DuBois, Pennsylvania, 15801.
3. Defendant Department of General Services Eq. of the Commonwealth of Pennsylvania (hereinafter referred to as Defendant General Services) is an agency of the Commonwealth of Pennsylvania with an address of 2221 Forster Street, Harrisburg, Dauphin County, PA 17125.

4. Defendant Department of Auditor General of the Commonwealth of Pennsylvania (hereinafter referred to as Defendant Auditor General) is an agency of the Commonwealth of Pennsylvania with an address of Bureau of State-Aided Audits, Room 316D, Finance Building Harrisburg, Dauphin County, PA 17120.

5. At all times material hereto, Plaintiff Harry Jefferson Ripley, Jr. was the owner and operator of a 1999 Harley Davidson, Roadking Classic Motorcycle, Pennsylvania registration plate number 6ST3T, Pennsylvania title number 53698532, (hereinafter referred to as "Plaintiff motorcycle"). The Plaintiff motorcycle was then and there being operated by the Plaintiff, Harry Jefferson Ripley with the knowledge, consent and permission of the owner of the vehicle.

6. At all times material hereto, Defendant General Services was the owner of a 1999 Dodge Stratus, Pennsylvania registration plate number 19459PA, Pennsylvania title number 53388873901 (hereinafter referred to as Defendant vehicle. The Defendant vehicle was then and there being operated by Defendant Belin, an agent and employee of Defendant Auditor General. The Defendant vehicle was then and there being operated by the Defendant, Matthew T. Belin, with the knowledge, consent and permission of the owners of the vehicle.

7. East Park Avenue, also known as State Route 4014, is a public roadway that runs in an east-west direction through the town of Dubois, Clearfield County, Pennsylvania,

8. On or about May 22, 2000, at approximately 11:34 a.m., Plaintiff was traveling east on East Park Avenue. Defendant Belin, in the course of his employment with the Defendant Auditor General, was driving a vehicle owned by Defendant General Services, west on East Park Avenue. Defendant attempted to make a left turn into a Sheetz parking lot directly in the lane of travel of the Plaintiff motorcycle causing a collision between the two vehicles. Plaintiff was thrown from his motorcycle and the Defendant vehicle hit his left leg thereby causing severe and serious

injuries to the Plaintiff as more fully set forth herein.

9. The injuries and damages set forth herein were the direct and proximate result of the negligence of the Defendants generally, individually, jointly and severally, and in the following respects:

- a. In operating said vehicle at a high, dangerous and reckless speed under the circumstances;
- b. In failing to keep said vehicle under proper control under the circumstances;
- c. In operating said vehicle in an erratic manner;
- d. In failing to operate said vehicle with proper caution;
- e. In continuing to operate said vehicle in a direction toward the Plaintiff motorcycle vehicle when Defendant Belin saw or in the exercise of reasonable care should have seen that further operation in that direction would cause a collision;
- f. In failing to operate the brakes in such a manner that said vehicle could be stopped before causing a collision;
- g. In failing to stop said vehicle when he knew or should have known, of the danger to approaching vehicles;
- h. In failing to yield the right of way;
- i. In failing to observe with reasonable care the traffic, including the location of Plaintiff's motorcycle;
- j. In being inattentive and failing to maintain a proper lookout of the road and the conditions of traffic surrounding said vehicle;
- k. In failing to sound a horn or give other warning to Plaintiff as Defendant Belin was operating said vehicle;
- l. In failing to keep and maintain said vehicle in proper mechanical condition;
- m. In failing to properly inspect said vehicle to determine any mechanical defects;
- n. In the alternative, in continuing to operate said vehicle on a public roadway in disregard of the safety of other persons, such as the Plaintiff, when Defendant Belin knew or in the exercise of reasonable care should have known, that said vehicle had a mechanical problem or problems which could result in an accident and

of not ceasing the use of said vehicle until a person or persons qualified to do so inspected said vehicle for mechanical defects and remedied same, if any;

- o. In failing to observe the care and caution required under the circumstances;
- p. In violating the ordinances of the Township of Dubois and the County of Clearfield and the Motor Vehicle Code of the Commonwealth of Pennsylvania, including but not limited to:
  - (1) 75 Pa. C.S.A. Sections 3331 and 3332 by turning left directly in the path of the Plaintiff motorcycle;
  - (2) 75 Pa. C.S.A. Section 3361 by driving a vehicle at a speed greater than was reasonable and prudent under the circumstances having regard to the actual and potential hazards then existing;
  - (3) 75 Pa. C.S.A. Section 3361 by failing to have due regard for the actual and potential hazards then and there existing;
  - (4) 75 Pa. C.S.A. Section 3361 by operating said vehicle at a speed greater than would permit Defendant driver to bring said vehicle to a stop within the assured clear distance;
  - (5) 75 Pa. C.S.A. Section 3361 by failing to drive at a safe and appropriate speed when special hazards exist with respect to other traffic;
  - (6) 75 Pa. C.S.A. Section 3361 by failing to drive at a safe and appropriate speed by reason of weather and/or highway conditions;
  - (7) 75 Pa. C.S.A. Section 3361 by failing to yield the right-of-way of approaching traffic when entering roadway; and
  - (8) 75 Pa. C.S.A. Section 3714 by failing to drive at a safe and reasonable speed when special hazards existed with respect to other traffic;
  - (9) 75 Pa. C.S.A. Section 3714 by recklessly driving a vehicle in careless disregard for the safety of persons including Plaintiffs;
- q. With respect to Defendant General Services, negligent entrustment of its vehicle to Defendant Belin, when it knew or should have known that Defendant Belin was not capable of operating said vehicle;
- r. With respect to Defendant General Services and Defendant Auditor General, in failing to maintain proper and adequate supervision over the activities of their agents, servants, employees and/or tenants;

- r. With respect to Defendant General Services and Defendant Auditor General, in failing to control the conduct of agents, servants, employees in their conduct of activities with regard to the Defendant vehicle rack they knew or in the exercise of reasonable care and diligence should have known;
- s. In otherwise failing to accord Plaintiff the care owed to them under all the attendant circumstances;
- t. In otherwise being negligent and careless, in otherwise acting or failing to act in connection with the operation, maintenance and use of said vehicle in such a manner as would cause injury, under the facts and circumstances as set forth in this Complaint, and as shall appear from the facts of this case, such facts presently within the knowledge or under the control of the Defendants or others, and which will be revealed during the course of discovery and trial in this case, including testimony from Defendants, or others, and from records, documents, or other writings in Defendants' possession or produced during discovery or trial.

10. As the result of the negligence of the Defendants as aforesaid, Plaintiff, Harry Jeff

Ripley, Jr., sustained the following injuries all of which are, or may be, of a permanent nature and which are more fully set forth in his medical records and reports:

- a. Injuries to the bones, muscles tissues and ligaments of neck, back, shoulders, arms, chest, spine, hips, legs and other parts of his body;
- b. Crush injury to left lower leg with hematoma;
- c. Significant skin loss on left lower leg;
- d. Ulcer on left lower leg as a result of the crush injury;
- e. Various contusions, lacerations and/or abrasions;
- f. Swelling, tenderness and bruising to his lower extremities;
- g. Significant scarring and thickening of the skin of the left lower leg;
- h. Ecchymosis and blistering of the lower left leg;
- i. Right buttock pain radiating into her knees and ankle;
- j. Pain, achiness and burning sensation in his left leg;
- k. Internal injuries and shock to the nervous system;

1. Permanent injuries, disfigurement and disability;
- m. Serious impairment of bodily functions;
- n. Other severe and serious injuries as set forth more fully in Plaintiff's medical records and reports;
- o. In the alternative, if any injury or medical condition is proven to be preexisting, aggravation of such preexisting injuries or medical conditions.

11. As the result of these injuries Plaintiff Harry Jefferson Ripley, Jr. has sustained the following damages:

- a. He has suffered serious, severe and permanent injuries to his body;
- b. He has suffered and will suffer great pain, suffering, inconvenience, humiliation, embarrassment and mental anguish and loss of the ordinary pleasures of life and family life;
- c. He has been and will be required to expend sums of money for medical attention, hospitalization, medical supplies, surgeries, debridements and lancing, surgical appliances, medicines and attendant services;
- f. His general health, strength and vitality have been impaired and will be impaired in the future;
- f. Permanent injuries, disfigurement and disability;
- g. Loss of income and impairment of future earning capacity;
- h. Other damages to be determined.

12. By reason of the aforesaid injuries to her husband, Harry Jefferson Ripley, Jr., and as a result of the negligence of the Defendants as aforesaid, Plaintiff, Evelyn Ripley, has been and will be in the future deprived of the services, assistance, and companionship, and consortium of her husband and loss of enjoyment of the ordinary pleasures of life, including marital and family life, and has sustained damages as a result thereof.

WHEREFORE, in consideration of the foregoing, Plaintiffs demand judgment against Defendants jointly and severally in excess of the arbitration limits of this court, at the proper costs and charges thereto.

1. Plaintiff, Harry Jefferson Ripley, Jr. and Evelyn Ripley, his wife, are adult individual residing at 35 Cardinal Drive, DuBois, Clearfield County, Pennsylvania 15801.
2. Defendant, Matthew T. Belin is an adult individual residing at 300 Treasure Lake, DuBois, Pennsylvania, 15801.
3. Defendant Department of General Services Eq. of the Commonwealth of Pennsylvania (hereinafter referred to as Defendant General Services) is an agency of the Commonwealth of Pennsylvania with an address of 2221 Forster Street, Harrisburg, Dauphin County, PA 17125.

4. Defendant Department of Auditor General of the Commonwealth of Pennsylvania (hereinafter referred to as Defendant Auditor General) is an agency of the Commonwealth of Pennsylvania with an address of Bureau of State-Aided Audits, Room 316D, Finance Building Harrisburg, Dauphin County, PA 17120.

5. At all times material hereto, Plaintiff Harry Jefferson Ripley, Jr. was the owner and operator of a 1999 Harley Davidson, Roadking Classic Motorcycle, Pennsylvania registration plate number 6ST3T, Pennsylvania title number 53698532, (hereinafter referred to as "Plaintiff motorcycle"). The Plaintiff motorcycle was then and there being operated by the Plaintiff, Harry Jefferson Ripley with the knowledge, consent and permission of the owner of the vehicle.

At all times material hereto, Defendant General Services was the owner of a 1999 Dodge Stratus, Pennsylvania registration plate number 19459PA, Pennsylvania title number 53388873901 (hereinafter referred to as Defendant vehicle). The Defendant vehicle was then and there being operated by Defendant Belin, an agent and employee of Defendant Auditor General. The Defendant vehicle was then and there being operated by the Defendant, Matthew T. Belin, with the knowledge, consent and permission of the owners of the vehicle.

7. East Park Avenue, also known as State Route 4014, is a public roadway that runs in an east-west direction through the town of Dubois, Clearfield County, Pennsylvania,

8. On or about May 22, 2000, at approximately 11:34 a.m., Plaintiff was traveling east on East Park Avenue. Defendant Belin, in the course of his employment with the Defendant Auditor General, was driving a vehicle owned by Defendant General Services, west on East Park Avenue. Defendant attempted to make a left turn into a Sheetz parking lot directly in the lane of travel of the Plaintiff motorcycle causing a collision between the two vehicles. - i. In failing to observe with reasonable care the traffic, including the location of Plaintiff's motorcycle;
- j. In being inattentive and failing to maintain a proper lookout of the road and the conditions of traffic surrounding said vehicle;
- k. In failing to sound a horn or give other warning to Plaintiff as Defendant Belin was operating said vehicle;
- l. In failing to keep and maintain said vehicle in proper mechanical condition;



8. On or about May 22, 2000, at approximately 11:34 a.m., Plaintiff was traveling east on East Park Avenue. Defendant Belin, in the course of his employment with the Defendant Auditor General, was driving a vehicle owned by Defendant General Services, west on East Park Avenue. Defendant attempted to make a left turn into a Sheetz parking lot directly in the lane of travel of the Plaintiff motorcycle causing a collision between the two vehicles. Plaintiff was thrown from his motorcycle and the Defendant vehicle hit his left leg thereby causing severe and serious

injuries to the Plaintiff as more fully set forth herein.

9. The injuries and damages set forth herein were the direct and proximate result of the negligence of the Defendants generally, individually, jointly and severally, and in the following respects:

- a. In operating said vehicle at a high, dangerous and reckless speed under the circumstances;
- b. In failing to keep said vehicle under proper control under the circumstances;
- c. In operating said vehicle in an erratic manner;
- d. In failing to operate said vehicle with proper caution;
- e. In continuing to operate said vehicle in a direction toward the Plaintiff motorcycle vehicle when Defendant Belin saw or in the exercise of reasonable care should have seen that further operation in that direction would cause a collision;
- f. In failing to operate the brakes in such a manner that said vehicle could be stopped before causing a collision;
- g. In failing to stop said vehicle when he knew or should have known, of the danger to approaching vehicles;
- h. In failing to yield the right of way;
- i. In failing to observe with reasonable care the traffic, including the location of Plaintiff's motorcycle;
- j. In being inattentive and failing to maintain a proper lookout of the road and the conditions of traffic surrounding said vehicle;
- k. In failing to sound a horn or give other warning to Plaintiff as Defendant Belin was operating said vehicle;
- l. In failing to keep and maintain said vehicle in proper mechanical condition;
- m. In failing to properly inspect said vehicle to determine any mechanical defects;
- n. In the alternative, in continuing to operate said vehicle on a public roadway in disregard of the safety of other persons, such as the Plaintiff, when Defendant Belin knew or in the exercise of reasonable care should have known, that said vehicle had a mechanical problem or problems which could result in an accident and

of not ceasing the use of said vehicle until a person or persons qualified to do so inspected said vehicle for mechanical defects and remedied same, if any;

- o. In failing to observe the care and caution required under the circumstances;
- p. In violating the ordinances of the Township of Dubois and the County of Clearfield and the Motor Vehicle Code of the Commonwealth of Pennsylvania, including but not limited to:
  - (1) 75 Pa. C.S.A. Sections 3331 and 3332 by turning left directly in the path of the Plaintiff motorcycle;
  - (2) 75 Pa. C.S.A. Section 3361 by driving a vehicle at a speed greater than was reasonable and prudent under the circumstances having regard to the actual and potential hazards then existing;
  - (3) 75 Pa. C.S.A. Section 3361 by failing to have due regard for the actual and potential hazards then and there existing;
  - (4) 75 Pa. C.S.A. Section 3361 by operating said vehicle at a speed greater than would permit Defendant driver to bring said vehicle to a stop within the assured clear distance;
  - (5) 75 Pa. C.S.A. Section 3361 by failing to drive at a safe and appropriate speed when special hazards exist with respect to other traffic;
  - (6) 75 Pa. C.S.A. Section 3361 by failing to drive at a safe and appropriate speed by reason of weather and/or highway conditions;
  - (7) 75 Pa. C.S.A. Section 3361 by failing to yield the right-of-way of approaching traffic when entering roadway; and
  - (8) 75 Pa. C.S.A. Section 3714 by failing to drive at a safe and reasonable speed when special hazards existed with respect to other traffic;
  - (9) 75 Pa. C.S.A. Section 3714 by recklessly driving a vehicle in careless disregard for the safety of persons including Plaintiffs;
- q. With respect to Defendant General Services, negligent entrustment of its vehicle to Defendant Belin, when it knew or should have known that Defendant Belin was not capable of operating said vehicle;
- r. With respect to Defendant General Services and Defendant Auditor General, in failing to maintain proper and adequate supervision over the activities of their agents, servants, employees and/or tenants;

- r. With respect to Defendant General Services and Defendant Auditor General, in failing to control the conduct of agents, servants, employees in their conduct of activities with regard to the Defendant vehicle rack they knew or in the exercise of reasonable care and diligence should have known;
- s. In otherwise failing to accord Plaintiff the care owed to them under all the attendant circumstances;
- t. In otherwise being negligent and careless, in otherwise acting or failing to act in connection with the operation, maintenance and use of said vehicle in such a manner as would cause injury, under the facts and circumstances as set forth in this Complaint, and as shall appear from the facts of this case, such facts presently within the knowledge or under the control of the Defendants or others, and which will be revealed during the course of discovery and trial in this case, including testimony from Defendants, or others, and from records, documents, or other writings in Defendants' possession or produced during discovery or trial.

10. As the result of the negligence of the Defendants as aforesaid, Plaintiff, Harry Jeff

Ripley, Jr., sustained the following injuries all of which are, or may be, of a permanent nature and which are more fully set forth in his medical records and reports:

- a. Injuries to the bones, muscles tissues and ligaments of neck, back, shoulders, arms, chest, spine, hips, legs and other parts of his body;
- b. Crush injury to left lower leg with hematoma;
- c. Significant skin loss on left lower leg;
- d. Ulcer on left lower leg as a result of the crush injury;
- e. Various contusions, lacerations and/or abrasions;
- f. Swelling, tenderness and bruising to his lower extremities;
- g. Significant scarring and thickening of the skin of the left lower leg;
- h. Ecchymosis and blistering of the lower left leg;
- i. Right buttock pain radiating into her knees and ankle;
- j. Pain, achiness and burning sensation in his left leg;
- k. Internal injuries and shock to the nervous system;

1. Permanent injuries, disfigurement and disability;
- m. Serious impairment of bodily functions;
- n. Other severe and serious injuries as set forth more fully in Plaintiff's medical records and reports;
- o. In the alternative, if any injury or medical condition is proven to be preexisting, aggravation of such preexisting injuries or medical conditions.

11. As the result of these injuries Plaintiff Harry Jefferson Ripley, Jr. has sustained the following damages:

- a. He has suffered serious, severe and permanent injuries to his body;
- b. He has suffered and will suffer great pain, suffering, inconvenience, humiliation, embarrassment and mental anguish and loss of the ordinary pleasures of life and family life;
- c. He has been and will be required to expend sums of money for medical attention, hospitalization, medical supplies, surgeries, debridements and lancing, surgical appliances, medicines and attendant services;
- f. His general health, strength and vitality have been impaired and will be impaired in the future;
- f. Permanent injuries, disfigurement and disability;
- g. Loss of income and impairment of future earning capacity;
- h. Other damages to be determined.

12. By reason of the aforesaid injuries to her husband, Harry Jefferson Ripley, Jr., and as a result of the negligence of the Defendants as aforesaid, Plaintiff, Evelyn Ripley, has been and will be in the future deprived of the services, assistance, and companionship, and consortium of her husband and loss of enjoyment of the ordinary pleasures of life, including marital and family life, and has sustained damages as a result thereof.

WHEREFORE, in consideration of the foregoing, Plaintiffs demand judgment against Defendants jointly and severally in excess of the arbitration limits of this court, at the proper costs and charges thereto.







The defendants have been advised by their attorney that subparagraphs (a) through (t) of Paragraphs 9 of the plaintiffs' Complaint are automatically denied by operation of law. The defendants demand strict proof of these allegations. The Department of General Services denies that it employed or that it was responsible for actions of Matthew T. Belin who was an employee of the Department of Auditor General at all relevant

times.

10. In answer to Paragraph 10 of the plaintiffs' Complaint, the defendants specifically deny that they have committed any negligence which was the proximate cause of the injuries and damages allegedly sustained by the plaintiffs and instead aver that they acted reasonably and with due care at all relevant times. In answer to subparagraphs (a) through (o) of Paragraph 10 of the plaintiffs' Complaint, after reasonable investigation, the Commonwealth defendants, are without knowledge or information sufficient to form a belief as to the truth or falsity of the averments contained therein; consequently, the same are denied and strict proof, thereof, to the contrary is demanded at the time of trial.

11. In answer to the averments contained in Paragraph 11 and subparagraphs (a) through (h) of the plaintiffs' Complaint, after reasonable investigation, the defendants, are without knowledge or information sufficient to form a belief as to the truth or falsity of the averments contained therein; consequently, the same are denied and strict proof, thereof, to the contrary is demanded at the time of trial.

12. In answer to the averments contained in Paragraph 12 of the plaintiffs' Complaint, after reasonable investigation, the defendants, are without knowledge or information sufficient to form a belief as to the truth or falsity of the averments

contained therein; consequently, the same are denied and strict proof, thereof, to the contrary is demanded at the time of trial.

In further answer, the defendants set forth the following New Matter.

NEW MATTER

By way of further and more complete answer to the plaintiffs' Complaint, these defendants set forth the following New Matter:

13. The cause of action against the defendants, is barred by the Doctrine of Sovereign Immunity.

14. By way of further defense, it is averred that the cause of action against the defendants, does not fall within one of the nine (9) categories enumerated by §8522 of Act 152, September 28, 1978, P.L. 788, as amended, 42 Pa. C.S.A. §8522.

15. By way of further defense, it is averred that the cause of action against the defendants, fails as a result of the failure of this defendants to receive actual written notice pursuant to §8555 of Act 152, September 28, 1978, P.L. 788, as amended, 42 Pa. C.S.A. §5522.

16. By way of further defense, it is averred that in the event that damages are awarded in this case, said damages are limited to the amounts and for the losses as set forth in §8528 of Act 152, September 28, 1978, P.L. 788, as amended, 42 Pa. C.S.A. §8528.

17. The rights of the plaintiffs in this action are diminished or fully barred by plaintiffs' contributory negligence in accordance with the provisions of the Pennsylvania Comparative Negligence Law, 42 Pa. C.S.A. §7102.

18. The injuries, losses, damages or occurrences alleged in the plaintiffs' Complaint were the result of an independent and intervening cause or causes over which the defendants, had no control or in any way participated.

19. The injuries, losses, damages or occurrences alleged in the plaintiffs' Complaint were the result of the assumption of the risk of such injuries, losses or damages by the plaintiffs.

20. All rights which might otherwise exist against these parties are barred in whole or in part by the applicable statutes of limitations, other similar statutes, contractual provisions and/or other fundamental provisions, including waiver, estoppel and laches.

21. Matthew T. Belin was an employee of the Department of Auditor General at the time of the subject accident and was acting within the scope of his employment at the time of the subject accident.





13. Plaintiffs have been advised and therefore aver that the allegations of Paragraph 13 set forth conclusions of law to which no response is required. If further response is required, it is denied that Plaintiffs' cause of action is barred by the doctrine of sovereign immunity. Proof is demanded. If it is found that Defendants do have sovereign immunity, which is hereby denied, it is averred that various exceptions to sovereign immunity set forth at 42 Pa. C.S.A. §8522(b), including, but not limited to the vehicle exception found at 42 Pa. C.S.A. §8522 (b)(1), are applicable in this case.

14. Plaintiffs have been advised and therefore aver, that the allegations of Paragraph 14 set forth conclusions of law to which no response is required. If further

answer is required, the allegations are denied. Proof is demanded. It is averred that various exceptions to sovereign immunity set forth at 42 Pa. C.S.A. §8522(b), including, but not limited to the vehicle exception found at 42 Pa. C.S.A. §8522 (b)(1), are applicable in this case.

15. Plaintiffs have been advised and therefore aver that the allegations of Paragraph 15 set forth conclusions of law to which no response is required. If further response is required, the allegations are denied. Proof is demanded. To the contrary, Plaintiffs provided actual written notice to the Defendants that they received within the six month period set forth at 42 Pa. C.S.A. §5522. A copy of the actual written notice letter sent to Pa. Dept. of General Services Eq. and Office of the Attorney General dated July 5, 2000 along with copies of the return receipts confirming delivery of the letters dated July 7, 2000 and July 20, 2000, respectively, are attached as Exhibit 1. A copy of the actual written notice letter sent to Pa. Dept. of Auditor General and Office of the Attorney General dated November 14, 2000 along with copies of the return receipts confirming delivery of the letters dated November 17, 2000 and Novermber 17, 2000, respectively, are attached as Exhibit 2.

16. Plaintiffs have been advised and therefore aver that the allegations of Paragraph 16 set forth conclusions of law to which no response is required. If further response is required, it is denied that Plaintiffs' damages and losses are limited by the provisions of 42 Pa. C.S.A. §8528. Proof is demanded.

19. Plaintiffs have been advised and therefore aver that the allegations of paragraph 19 set forth conclusions of law to which no answer is required. If further answer is required, Plaintiffs deny that the husband-plaintiff assumed any risk of injuries, losses or damages and therefore Plaintiffs' claims are not barred by the doctrine of assumption of the risk. Proof is demanded.

20. Plaintiffs have been advised and therefore aver that the allegations of paragraph 20 set forth conclusions of law to which no answer is required.
