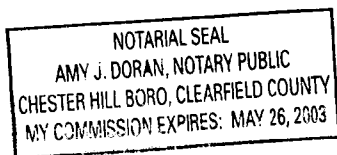



**COMPLAINT**

1. Plaintiff is Carl Keith, Jr., an individual, who resides at 504 Ida Street, Houtzdale, Clearfield County, Pennsylvania, 16651.

2. Defendants are Rodger Stone a/k/a Roger D. Stone and Nancy K. Stone, his wife, currently of 121 Walnut Street, Philipsburg, Pennsylvania, 16866.

3. Plaintiff is the owner of premises situate in the Borough of Houtzdale, Clearfield County, Pennsylvania, which were rented and occupied by the Defendants commencing in 1998.

4. The monthly rental for the residential premises was \$250.00 per month.

5. The Defendants paid the Plaintiff sporadically, unevenly, and moved out July 1, 2001.

6. The rent remaining unpaid on July 1, 2001, was \$2,450.00.

7. Plaintiff filed an action at District Justice Court and paid the costs in the amount

of \$78.50.

8. Interest at the legal rate of six (6%) percent is due and owing on the rent from July 1, 2001.

9. Despite Plaintiff's repeated demands for payment, the Defendants have failed and refused and continue to fail and refuse to pay any portion whatsoever.

**WHEREFORE**, Plaintiff demands that judgment be entered in favor of Plaintiff and against the Defendants in the amount of \$2,528.50, plus interest from July 1, 2001, and costs of suit.


