BEGINNING at a 3/4 inch rebar set, said rebar being northern most corner of Lot 2 of the above-mentioned subdivision, said rebar being the eastern most corner of the land herein conveyed and running:

THENCE, South 36 degrees 46 minutes 38 seconds West, a distance of 300.42 feet, along Lot 2 to a point in the centerline of Township Road T-460, said line passing through a 3/4 inch rebar set back 17.00 feet from said centerline;

THENCE, North 55 degrees 00 minutes 11 seconds West, 312.59 feet along the centerline of T-460 to a spike set;

Thence, North 38 degrees 47 minutes 29 seconds East, 300.94 feet through land of the Grantor to a 3/4 inch rebar set, said line passing through a 3/4 inch rebar set at 24.45 feet;

Thence, South 55 degrees 00 minutes 11 seconds East 302.01 feet through lands of the Grantor to a 3/4 inch rebar set and place of beginning.

TOGETHER with and subject to covenants, easements and restrictions of record.

Continuing 2.118 acres total, minus, 0.118 acre for the right-of-way of Township Road T-460, leaving 2.000 acres net and known as Lot No. 3 of the C.B. Danver Heirs Trust, Michael C.
