





**COMPLAINT**

AND NOW, comes Plaintiff, JAMES A. LABORDE, D.C., by and through his attorneys, BLAKLEY, JONES & MOHNEY, and files the following Complaint, of which the following is a statement:

1. Plaintiff is JAMES A. LABORDE, D.C., a Doctor of Chiropractic licensed to do business in the Commonwealth of Pennsylvania, with his business address being located at R.R. #1, Box 109, Du Bois, Clearfield County, Pennsylvania.
2. Defendant is PHILIP P. TABONE, an adult individual residing at 723 South Brady Street, Du Bois, Clearfield County, Pennsylvania.
3. That at all times material hereto, the Plaintiff practiced at the above address and offered his services to the general public.
4. That on or about March 5, 2001, the Defendant appeared at the offices of the Plaintiff seeking chiropractic services for shoulder and muscle pain and a pinched nerve.
5. That on March 5, 2001, the Plaintiff in furtherance of his practice, agreed to perform an examination, including cervical x-rays and chiropractic adjustment upon the Defendant, all of

which was requested by and accepted by the Defendant.

6. That on the aforesaid date, the Defendant informed the Plaintiff that he had medical insurance coverage through Highmark Blue Cross/Blue Shield and that all charges for services provided by the Plaintiff should be submitted to the Defendant's insurance provider. However, it was agreed by the Defendant that he would be responsible for all uninsured medical services or for any deductible amounts upon said insurance coverage.

7. That on his March 5, 2001 visit, the Defendant did pay to the Plaintiff an Eight Dollar (\$8.00) co-payment toward his financial obligation arising from the services provided by the Plaintiff to the Defendant on the aforesaid date.

8. That on March 7, 2001, March 9, 2001, March 12, 2001, March 14, 2001, and March 16, 2001, the Defendant reappeared at the offices of the Plaintiff and did request chiropractic adjustments, and in furtherance of said request, Plaintiff did perform chiropractic adjustments upon the body of the Defendant.

9. That the reasonable and customary charges for the initial examination of the Defendant on March 5, 2001, was Sixty Dollars (\$60.00), for the cervical x-ray, One Hundred Twenty-Five Dollars (\$125.00) and for the chiropractic adjustments provided to the Defendant, Forty Dollars (\$40.00) per visit.

10. That at the conclusion of each visit to Plaintiff's offices by the Defendant, the Defendant was presented with a billing for services provided, and he did acknowledge receipt of said billings with his signature on each visit. Copies of said billings are attached hereto and collectively marked as Exhibits "A-1" through "A-5."

11. The Plaintiff did submit the charges for the services provided to the Defendant to

Highmark Blue Cross/Blue Shield, as directed by the Defendant. Copies of said health insurance claim forms as submitted by the Plaintiff are attached hereto and marked as Exhibits "B", "C" and "D."

12. As a result of his reimbursement agreement with Highmark Blue Cross/Blue Shield, the Plaintiff was reimbursed Seventy-One Dollars (\$71.00) for the cervical x-rays provided to the Defendant by the Plaintiff on April 6, 2001, and as such, the Plaintiff accepted the aforesaid amount in full payment of the x-ray services provided to the Defendant.

13. That the Plaintiff was advised by Highmark Blue Cross/Blue Shield that the Defendant had not met his yearly deductible, and as such, the Plaintiff would not be reimbursed for the March 5, 2001, examination and the chiropractic adjustments provided to the Defendant on March 5, 2001, March 7, 2001, March 9, 2001, March 12, 2001, March 14, 2001, and March 16, 2001. A copy of the Major Medical Explanation of Benefits received by the Plaintiff from Highmark Blue Cross/Blue Shield are attached hereto and marked as Exhibits "E-1" and "E-2."

14. That because of the lack of applicable insurance reimbursement by the Defendant's medical insurance carrier, the Defendant had an outstanding balance for services provided by the Plaintiff to the Defendant in the amount of Two Hundred Ninety-Two Dollars (\$292.00), representing services provided from March 5, 2001, to March 16, 2001, with the Defendant being credited for his Eight Dollar (\$8.00) co-payment on March 5, 2001, and for the insurance payment and adjustment arising from the x-ray services provided to the Defendant.

15. Despite repeated requests for payment of the aforesaid amount, the Defendant has failed and refused to make payment of the amounts due and owing to the Plaintiff for the services provided to the Defendant.

16. That pursuant to the statement affixed to the Defendant's initial billing, finance charges have accrued on the Defendant's unpaid balance commencing ninety (90) days after his first billing (May 3, 2001), said finance charges being at one and one-half percent (1 ½ %) per month. A copy of a billing similar to that forwarded to the Defendant containing the Plaintiff's finance charge policy is attached hereto and marked as Exhibit "F."

17. That as a result of Defendant's failure to pay his outstanding indebtedness to the Plaintiff, the Plaintiff was forced to bring an action against the Defendant in the office of the District Magistrate, Patrick N. Ford, for which he incurred costs of Forty-Six Dollars (\$46.00).

WHEREFORE, Plaintiff demands judgment against the Defendant in the amount of \$292.00, plus Magistrate costs of \$46.00, along with finance charges on Defendant's unpaid balance at the rate of 1 ½ % per month commencing August 3, 2001, to date of judgment, along with interest and costs of suit.

WHEREFORE, Defendant requests your Honorable Court to dismiss Plaintiff's Complaint with prejudice.



The Petition of **JAMES A. LABORDE, D.C.**, by and through his attorneys,  
**BLAKLEY & JONES**, respectfully represents:

1. Petitioner, **JAMES A. LABORDE, D.C.**, is an adult individual, having his place of business at RR #1, Box 109, DuBois, Clearfield County, Pennsylvania.
2. Respondent, **PHILIP P. TABONE**, is an adult individual, with his last known address as 723 South Brady Street, DuBois, Clearfield County, Pennsylvania.
3. That by Complaint dated April 18, 2002, the Plaintiff brought suit against the Defendant for amounts due and owing the Plaintiff by the Defendant for chiropractic adjustments received by the Defendant by the Plaintiff.
4. That the matter was scheduled for arbitration by this Honorable Court for Friday, January 10, 2003.

5. That on January 8, 2003, Plaintiff, by his attorneys, **BLAKLEY & JONES**, did effect a settlement of the matter with the attorney for the Defendant, **JEFFREY S. 10. To date, the Defendant has failed and refused to complete the interrogatories or to pay to Plaintiff's counsel \$500.00 as ordered by this Honorable Court on October 20, 2003.

11. That the actions of the Defendant are in willful disobedience of this Honorable Court's Order of October 20, 2003.

- (b) order the said **PHILIP P. TABONE** to immediately complete the interrogatories propounded by the Plaintiff and served upon the Defendant in aid of execution of Plaintiff's judgment;
- (c) direct the Defendant to pay Plaintiff's attorney's fees in the amount of \$500.00; and
- (d) issue such other orders or punishments upon the Defendant as this Honorable Court may deem appropriate to vindicate its authority and to enforce its Order of October 20, 2003.
