COMPLAINT

NOW COMES, Plaintiff, Robert Mays, by and through his attorneys, The Hopkins Law Firm, and avers as follows:

1. Plaintiff is an individual who resides at 489 S. Honey Bear Way, Leconto, Florida 34461.
2. The property to be quieted is identified as Clearfield County Map No. 109-E15-35,

located in or about the intersection of Rt. 36 and Township Road 3014 in Chest Township, Clearfield County, Pennsylvania, which is generally known as to the Plaintiff and the Defendants as "the farm".
