**ALL** that certain piece or parcel of land situate in the Township of Beccaria, County of Clearfield and Commonwealth of Pennsylvania, bounded and described as follows, to wit:

**BEGINNING** at post corner formerly (Beech) and being the common corner dividing the James and Alexander Blain surveys; **THENCE** by line of Alexander Blain survey and Kratzer land North seven degrees and thirty minutes (7.30) East, seventy-four and eight-tenths (74.8) perches to a post near public road; **THENCE** by right of way of Public Road leading to Irvona, North eight degrees thirty minutes (8.30) East, forty-two and eight-tenths (42.8) perches to a post; **THENCE** East by lands of Witmer Land and Coal Co. twenty-one and two-tenths (21.2) perches to a post; **THENCE** by a private road and parallel with C.I.R.R. track South twenty-two degrees (22) East forty-three and four-tenths (43.4) perches, more or less, to point of curve leading to Y of C.I.R.R.; **THENCE** by right of way of arc of curve to same twenty-eight (28) rods, more or less, to point of a tangent; **THENCE** by said tangent South fifty-two degrees (52) West thirty (30) perches, more or less, to a post; **THENCE** South forty-two degrees (42) East six (6) perches to a post; **THENCE** by said tangent North fifty-two degrees (52) East, thirty (30) perches, more or less, to point of curve; **THENCE** by right of way of arc of curve twenty-eight (28) perches, more or less, to a point on right of way of C & I RR; **THENCE** by said right of way South fifty-seven degrees (57) East, nineteen and four-tenths (19.4) perches, more or less to a post; **THENCE** by lands of Witmer Land & Coal Co., South thirty-two degrees (32) West, fifteen and eight-tenths (15.8) perches to a post; **THENCE** by lands of the Witmer Land & Coal Co., South twenty-six degrees (26) and thirty-five minutes (26.35) East, forty-six and four-tenths (46.4) perches to a post on the division line, also tract line of one Kratzer, North eighty-five degrees (85) West one hundred (100) perches to place of beginning; **CONTAINING** forty-eight acres and one hundred and twenty perches (48 A. 120 P.) and being a part of the Alexander Blain Survey.

**EXCEPTING AND RESERVING** all the coal and other minerals with usual mining privileges as aforesaid.

**ALSO, EXCEPTING AND RESERVING** two (2) acres of surface sold and conveyed to Kratzer for an incline; and all of that tract of land sold and conveyed to Louis Irszak by deed dated December 5, 1946, recorded in Deed Book 380, at Page 375, and all the premises conveyed to the Pennsylvania Railroad by deed dated April 7, 1948, recorded in Deed Book 390 at Page 469.
