1. That Petitioner is Ronald M. Marshall, Operator License No. 24794372, of RD #2, Box 152, Ridge Road, Mahaffey, Clearfield County, Pennsylvania, 15757.

2. That Respondent is the Commonwealth of Pennsylvania, Department of Transportation.

3. That by two (2) official notices both dated March 20, 2002, Petitioner's operating privileges were suspended by Respondent in connection with Petitioner's Summary Convictions for two (2) offenses of Driving Under Suspension, 75 Pa. C.S.A. §1543 (a) occurring in Indiana County, Pennsylvania. Both convictions occurred in Indiana County on March 12, 2002 and were Citation Nos. A4906787-4 and A5632932-4. The first offense is alleged to have occurred on May 13, 2001, and the second offense is alleged to occurred on October 8, 2001.
