COMPLAINT

Now comes the Plaintiff, Murray's Ford, Inc. who hereby avers as follows:

Bresco Dennis Lingle is an adult individual whose address is 1221 ½ River Road, P O Box 502, Clearfield, PA 16830

Defendant is Murray's Ford, Inc. whose address is RR 1, Box 12, DuBois, PA 15801

On September 4, 2000, Bresco Dennis Lingle did enter into a Sales Agreement with Mr. Ray Moyer, Commercial Sales Manager for Murray's Ford, Inc.

The above mentioned Sales Agreement was to purchase a 2001 Ford F150 Extended Cab Truck.

The following items were added to Bresco Dennis Lingle's original order and he requested that they NOT appear on the Bill of Sale at the time he takes possession of the above mentioned vehicle.

The upfitting changes he requested were: Skid Plates, Power Adjustable Pedals, Power Driver's Seat and upgrade his registration to Class 5 (gross combination weight of 13,500).

As per Bresco Dennis Lingle's request a separate Invoice numbered 1 was created for the above mentioned items.

The total for the above mentioned items is \$709.04.

On November 17, 2000, Bresco Dennis Lingle took possession of the 2001 Ford F 150, Extended Cab, Vehicle Identification Number: 1FTPX18L51NA65087

On the above mentioned date, Bresco Dennis Lingle signed the above mentioned Invoice number 1.

Mr. Lingle then promised to send payment for Invoice number 1.

Numerous attempts were made to collect the monies due Murray's Ford from Bresco Dennis Lingle through telephone calls.

On May 30, 2001, correspondence was sent to Bresco Dennis Lingle requesting payment on the Invoice number 1.

On the above mentioned correspondence, there was no response from Bresco Dennis Lingle.

On January 23, 2002, I sent a final notice to Bresco Dennis Lingle requesting payment on the above mentioned Invoice number 1.

On the above mentioned final notice, I gave him ten days to pay the outstanding invoice to avoid legal action.

On the above mentioned final notice, it came back unclaimed from the U.S. Postal Service after they left three notices of intent to deliver.

On February 21, 2002, I filed a Civil Complaint at Judge Patrick Fords District Court 46-3-01, DuBois, PA against Bresco Dennis Lingle.

On the above mentioned filing I requested a Constable for delivery of the Civil complaint.

The total amount of our Civil Complaint was \$709.04 plus Court Costs.

The hearing was scheduled for March 26, 2002, at 9:10 am.

On the above mentioned complaint, there was no response from Bresco Dennis Lingle.

On March 26, 2002, we were awarded Judgment by Default for the amount of \$802.04.

On April 7, 2002, we received correspondence from Attorney Richard H. Milgrub requesting information on the above mentioned Complaint, which I faxed to Mr. Milgrub on this date.

On April 19, 2002, Mr. Milgrub contacted Mr. Ray Moyer requesting a breakdown of the invoice charges. This information was faxed to him on this date.

WHEREFORE, Plaintiff demands judgment against Defendant in the amount of \$802.04, plus interest, court costs and such other reasonable costs as the court may allow.
