AND NOW, comes the Plaintiff, **SUSAN R. GRAY**, by her attorneys, **BLAKLEY, JONES & MOHNEY**, who files the within Complaint against the above-captioned Defendant and in support thereof avers the following:

1. Plaintiff **SUSAN R. GRAY** is an adult individual residing at R.D. # 4, Box 311A, DuBois, Clearfield County, Pennsylvania 15801.
2. Defendant **ROBERT E. CURRY** is an adult individual with a last known address at 8 Shaffer Avenue, DuBois, Clearfield County, Pennsylvania 15801.
3. On or about August of 2001, Plaintiff loaned Defendant \$1,200.00, pursuant to a valid and enforceable oral agreement whereby Defendant agreed to pay back Plaintiff the monies he borrowed, which loan was interest-free.
4. On or about September 11, 2001, Plaintiff again, pursuant to a valid and enforceable oral agreement, loaned Defendant money, this time in an amount of \$1,000.00, interest-free, to which Defendant promised to reimburse Plaintiff.

5. To date, Defendant has only reimbursed Plaintiff \$200.00.




11. The Defendant feels that the reasonable value of these items is Five hundred dollars (\$500.00).
