EXHIBIT "A"

ALL that parcel of land being one-half of Lot No. 208 and the whole of Lot No. 209 in the Kittaning Coal Company plan of the Village of Woodward recorded April 14, 1896 in Clearfield County Misc. Book 92 at Page 620, in the Township of Woodward, County of Clearfield and State of Pennsylvania, bounded and described as follows: (all courses according to Magnetic Meridian of 1891):

BEGINNING at a post on the South side of Railroad Street leading from Houtzdale to Ginter in the center of Lot 208 and running through the center of said Lot South $42^{\circ} 11'$ East, one hundred eighty (180) feet to the North side of First Avenue; thence along said Avenue South $47^{\circ} 49'$ West, one hundred fifty (150) feet to post on other lands of now or formerly, Caroline Bartosh Simko; thence along other lands of said Simko North $42^{\circ} 11'$ West one hundred eighty (180) feet to post at the South side of said Railroad Street; thence along said Railroad Street North $47^{\circ} 49'$ East, one hundred fifty (150) feet to the post in the middle of Lot No. 208, the place of beginning.
