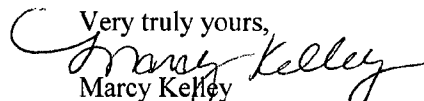

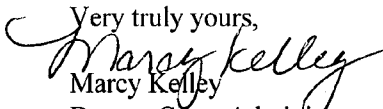

Merial Limited, Plaintiff in the above-captioned action, through their attorney, Joseph Colavecchi, Esquire, files this Complaint and respectfully avers as follows:

1. Plaintiff is Merial Limited a corporation authorized to do business under the laws of the Commonwealth of Pennsylvania having its principal place of business at 27 Knightsbridge, London SW1ZQT.

2. Defendant is Richard W. Mackey, t/d/b/a Shechinah Mobile Veterinary Practice, having his principal place of business at R.D. #3, Box 147, DuBois, Pennsylvania 15801.

3. Plaintiff entered into a Credit Agreement with Defendant on July 12, 2000, a copy of which is attached hereto and marked Exhibit "A".

4. Plaintiff at the oral instance and request of Defendant, sold from Merial Limited the items at the times and amounts as are

more fully set forth in the true and correct copies of the statements attached to this Complaint, marked Exhibit "B" and made a part hereof.

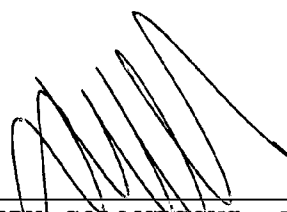
4. The prices for the said merchandise were the fair, reasonable, and market prices of the same at the times they were sold to said Defendant, and further are what Defendant agreed to pay therefor.

5. All of the items ordered by the Defendant have been delivered to Defendant and accepted by him and all items are and have been in his possession.

6. Plaintiff has demanded payment of the said merchandise in the total amount of Three Thousand Nine Hundred Eighty-five Dollars and Forty-seven Cents (\$3,985.47) from Defendant, but Defendant has refused and still refuses to pay the same or any part thereof.
