





COMPLAINT

1. The Plaintiff is a corporation organized and existing under the laws of the Commonwealth of Pennsylvania, with its place of business in the Borough of Philipsburg, Centre County, Pennsylvania.

2. The Defendant is an individual residing in Osceola Mills, Clearfield County, Pennsylvania and conducting a business under the name of Central Supply Company.

3. That from November 2, 1960 until March 3, 1961, the Plaintiff at the oral request of the Defendant sold and delivered to the Defendant certain goods and merchandise in the amount of \$1,090.56 as more fully set out in the statement and invoices hereto attached, marked Exhibit "A" and made a part hereof.

4. That the prices charged the Defendant by the Plaintiff were fair and reasonable at the time they were made, were the same as those charged other customers of the Plaintiff for the same type and quantity of goods and merchandise and were the prices Defendant agreed to pay for the same.

5. That Defendant has made no payment to the Plaintiff so that there remains due the Plaintiff the sum of \$1,090.56.

6. The Plaintiff has demanded payment from the Defendant of the amount due, but Defendant has refused and still refuses to pay the same or any part thereof.

WHEREFORE, Plaintiff demands judgment against the Defendant in the amount of \$1,090.56 with interest from March 3, 1961.
