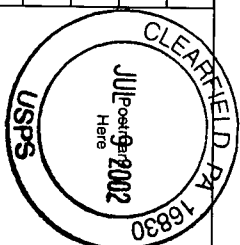

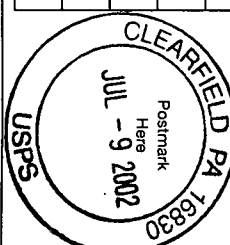


NOW, comes the Plaintiff, Bridget Beveridge who hereby avers as follows:

1. Bridget Beveridge, is an adult individual, whose address is RR1 Box 547A, 98 Jasmine Lane, Morrisdale, Pennsylvania 16858.
2. Defendant is Bigler Boyz, whose address is Box 381, Bigler, Pennsylvania 16825.
3. Car was towed from Interstate 80 on December 14, 2001 by the defendant, Bigler Boyz and was not towed to the car shop that I told them to.
4. Bigler Boyz called and told my father that they could fix the car with an "almost" perfectly new engine and told my dad that the car would be done in 24-48 hours after they received the engine.
5. December 25, picked up car that evening and paid \$1,100.00 on my bill which included unauthorized visits to other shops.
6. December 26, took my car to work and made it only half way to State College and the car completely overheated and the heater started blowing cold air.
7. Bigler Boyz once again came and towed my car back to their shop and told us that the problem was a backwards belt that they had put on the water pump.
8. December 27, picked up my car after they told me it was ready to go and that they drove it everywhere and didn't have a problem with it.
9. December 28, took my car to work once again and didn't make it because my car overheated again. I called

Bigler Boyz and they came and towed it back to their shop.

10. January 5, my car is still not done. My dad calls to find out where it is and was told that my car was sent to Frank Nelson's house to be worked on without my permission.
11. Bigler Boyz also said that they didn't know what was wrong with my car and told me that they would tow it to the dealership in Altoona and let me drive it from a block away so that I could trade it without it having any noticeable problems.
12. January 11, found out that my car was done that evening but was at Butler Chevrolet, without my permission. They said that Butler's were programming my computer.
13. January 12, my dad took my car for a ride to see if it was finally fixed. He took it halfway to Clearfield and it overheated. My dad called Bigler Boyz and they wouldn't even go look at it, they said that they had no idea what was wrong with it after they told me that they knew exactly what was wrong before.
14. My dad took my car to Butler Chevrolet to finally trade it. At the dealership, my dad and a mechanic noticed that there was antifreeze leaking from my car and that it was the wrong color.
15. I traded my car in at Butler's since I already wasted so much money and time trying to get it fixed. I ended up taking a \$2,500 loss on my vehicle due to the problems that it had suffered with Bigler Boyz.
16. Plaintiff is suing for the following amounts:
 - a. \$1,100.00 - payment paid to Bigler Boyz on December 25
 - b. \$2,500.00 - loss I took on my car when I traded it in
 - c. Approximately \$45.00 - paid to Butler's when I picked up my car on January 11 (not included in magistrate's ruling)
 - d. \$101.00 - magistrate filing costs
 - e. \$686.57 - remainder of bill that I owe (recommended to file by magistrate.)


