COMPLAINT

1. Plaintiff, D.C. Guelich Explosive Company, Inc. (herein as "Guelich"), is a Pennsylvania Corporation with its principal place of business at RD #3, Box 125A Clearfield, Clearfield County PA 16830.

2. Defendant, Ed Hanslovan Coal Company, Inc., (herein as "Hanslovan") is a Pennsylvania Corporation, which at all times pertinent hereto, operated at the Allport-cutoff in Morrsdale, Clearfield County, Pennsylvania 16858.

3. Jurisdiction and Venue of this honorable court is based upon the Defendant being located in Clearfield County, and the goods and services subject of this complaint having been provided here.

4. On various dates between January and April of 2001, Guelich at the specific request of Hanslovan provided explosive goods and services to Hanslovan as more fully itemized on Guelich's

invoices, true and correct copies of which are attached hereto, marked collectively as Exhibit "1", and made a part here of.

5. The Defendant received and accepted the explosive goods and services for the agreed said and fair prices.

6. Despite the performance of all conditions precedent by Guelich, Hanslovan has failed to pay Guelich the balance due for said goods and services which, pursuant to the running account between the parties, amounted to \$51,659.21 as of May 31, 2001, as more fully shown by a true and correct copy of the statement attached hereto, marked as Exhibit "2", and made a part hereof.

7. Hanslovan filed a petition under Chapter 11 of the Bankruptcy Code on May 21, 2001 at No. 01-25362bmm, in the United States Bankruptcy Court for the Western District of Pennsylvania, which was dismissed on June 7, 2002, per the true copy of the docket attached hereto, marked as Exhibit "3", and made a part hereof.

8. During the pendency of bankruptcy, the debtor filed Schedules and Statement of Financial Affairs signed by its President, Ed Hanslovan, under penalty of perjury, dated June 13, 2001 admitting the principal debt to Guelich in the amount of \$50,720.59 as shown by true and correct copies of page two of the Schedules and the signature page for the Schedules which are collectively attached hereto, marked as Exhibit "4", and made a part hereof.

9. Guelich is entitled to contractual service charges at a rate of one and half (1 ½) percent per month which from June 1, 2001 through August 1, 2002 amount to no less than \$10,651.32 bringing the total of principal and services to \$61,371.91.

WHEREFORE, Plaintiff, D.C. Guelich Explosive Company, demands judgment against Defendant, Ed Hanslovan Coal Co., Inc., in the amount \$61,371.91 plus appropriate additional service charges, plus court costs.
