ORDINANCE NO. 2002-15

AN ORDINANCE OF LAWRENCE TOWNSHIP, CLEARFIELD COUNTY, PENNSYLVANIA, VACATING A PORTION OF TOWNSHIP ROAD 873, THE CALADONIA PIKE, FROM ELK COUNTY BORDER TO GOSHEN TOWNSHIP LINE, LAWRENCE TOWNSHIP, CLEARFIELD COUNTY, PENNSYLVANIA.

BE IT ENACTED AND ORDAINED by the Board of Supervisors of the Township of Lawrence, and it is hereby enacted and ordained by the authority of the same as follows:

WHEREAS, a request in writing has been presented to the Board of Supervisors of Lawrence Township, Clearfield County, Pennsylvania, by and on behalf of landowners within the Township, surrounding and abutting Township Road 873, the Caladonia Pike, requesting that the Township Supervisors vacate that portion of the road from the Elk County border to Goshen Township line; and

WHEREAS, the Lawrence Township Supervisors gave public notice and written notice to the owners adjacent to Township Road 873 ten (10) days prior to the hearing that was held on June 18, 2002 at 6:45 p.m. to inquire into the merits of vacating the Caladonia Pike;

AND WHEREAS, after public hearing at which no one appeared to object to said action, the Board of Supervisors are of the opinion that said Caladonia Pike, Road 873 is not necessary to the public and the vacating of same would present an unnecessary and undue hardship upon the Township.

NOW THEREFORE BE IT ORDAINED:

1. That Township Road 873, the Caladonia Pike, from Elk County border to Goshen Township be and it is hereby vacated and removed from the Lawrence Township Road System.

2. The Lawrence Township Secretary is directed to record this Ordinance together with the attached map of the road being vacated in the Prothonotary's Office of the Court of Common Pleas, of Clearfield County.

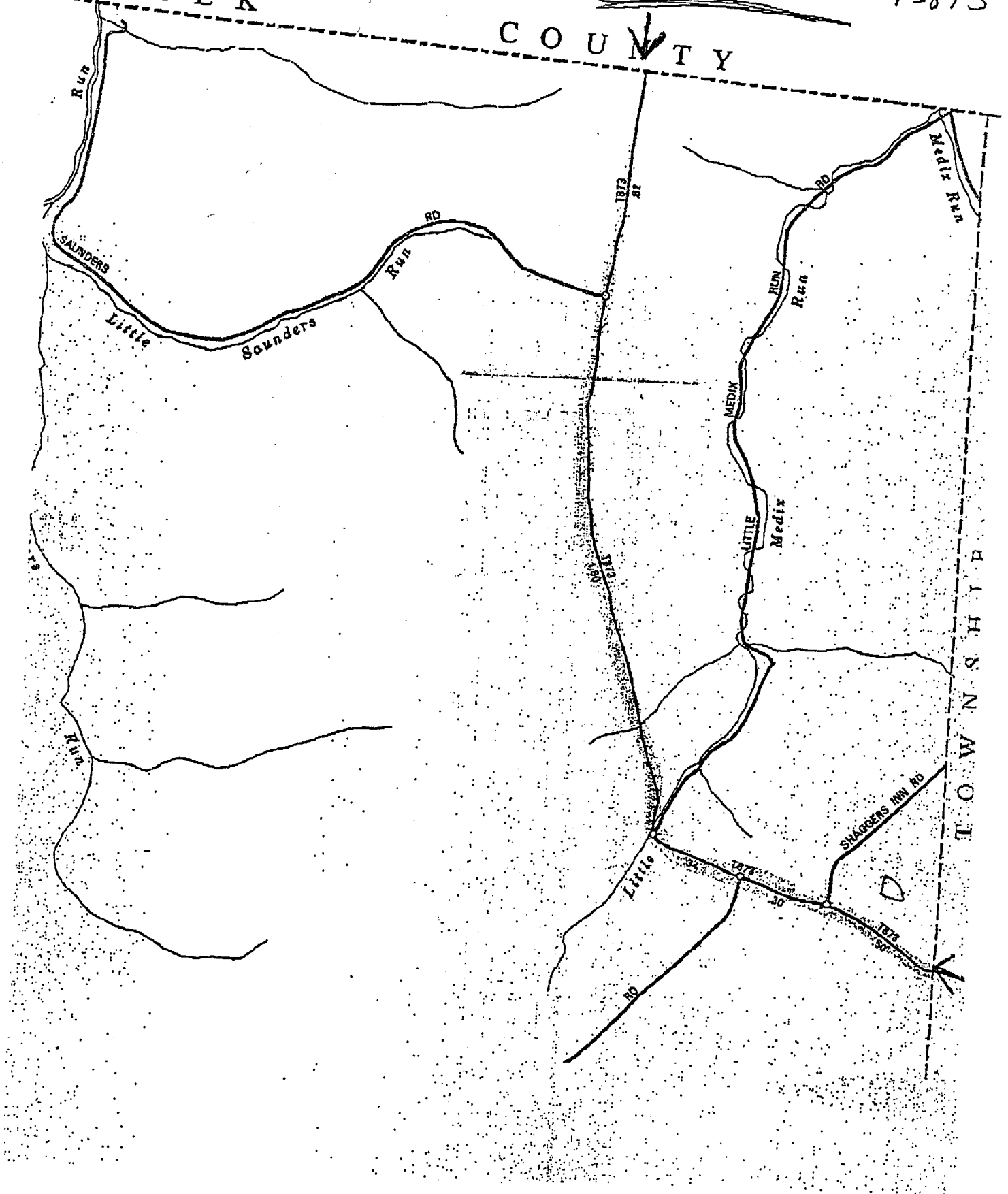
