COMPLAINT

1. Plaintiff is a corporation having offices at 2301 Highway, Deridder, LA 70634.
2. Defendant is a corporation having its offices or place of business at RR 3, Box 566-H, Corwensville, Clearfield County, Pennsylvania 16833.
3. On or about February 12, 1998, the Defendant made an application to the Plaintiff for certain insurance coverage.
4. At the specific request and instance of Defendant, Plaintiff issued a certain policy numbered 98WCPAL122905.
5. Defendant received and accepted the aforementioned coverage.
6. Plaintiff avers that said policy was canceled or otherwise terminated.
7. Plaintiff avers that at the inception of the policy period Defendant paid an estimated premium based on Defendant's estimated payroll for the policy term.
8. Plaintiff avers that actual premiums for the policy term were to be determined from Defendant's actual payroll over the policy period, with Defendant's payroll being subject to audit.
9. Plaintiff avers that if upon audit, actual payroll exceeded the estimated payroll, premiums to cover the additional exposure would be owed.

10. Plaintiff avers that premiums of \$9,514.46, as determined by audit are due, owing and unpaid, as is more specifically shown by a true and correct copy of Plaintiff's final audit billing, which has been attached hereto, marked Exhibit A" and made a part hereof..

11. Plaintiff avers that during the course of dealings between the parties, Defendant executed and delivered to Plaintiff six (6) checks for payment of monies due and owing Plaintiff, copies of which are attached hereto, respectively marked Exhibits B-1" through B-3" and made a part hereof.

12. Plaintiff avers that the aforementioned check(s) were not paid by Defendant's bank for the reason that there were not sufficient funds on deposit in Defendant's account in said bank, to cover said check(s).

13. Plaintiff further avers that the total principal amount due for the redemption of said check(s) is \$10,637.79.

14. Plaintiff avers that in addition to the foregoing sums, Plaintiff is due the sum of \$13.88 from Defendant as the result of shortages appearing upon Defendant's July 1988 reports.

15. Plaintiff avers that the total indebtedness of Defendant to Plaintiff amounted to \$20,166.13.


16. Plaintiff avers that in partial payment of said debt, Defendant made payments to the Plaintiff totaling \$8,343.00, thereby reducing the total amount owed to Plaintiff to \$11,823.13.

17. Plaintiff claims legal interest, as damages, on the liquidated debt from March 29, 1999.

18. Although repeatedly requested to do so by Plaintiff, Defendant has willfully failed and refused to pay the amount due Plaintiff or any part thereof.

WHEREFORE, Plaintiff demands Judgment against Defendant in the amount of \$11,823.13, with appropriate additional interest and costs.


