**PETITION FOR CHANGE OF NAME**

TO THE HONORABLE COURT:

NOW COMES, Petitioner, Niccoma Myers, by and through her attorneys, The Hopkins Law Firm, respectfully requests that this Court order a change of name for her minor child as named herein, in accordance with 54 Pa.Cons. Stat. Section 701 et seq., and petitions the Court as follows:

1. The Petitioner is Niccoma Myers who currently resides at PO Box 94, Penfield, Clearfield County, Pennsylvania.
2. The Petitioner is the natural mother of Kaylee Rae Clark who was born on August 7, 2000.
3. The natural father of Kaylee Rae Clark is Kevin Griffin who currently resides at PO Box 213, Luxor, Pennsylvania.
4. From her birth on August 7, 2000, Kaylee Rae Clark resided with her mother, Niccoma Myers.
5. Initially, Greg A. Clark, II, who resides at RD#1, Box 332A-1, Brookville, Jefferson County was thought to be the father and same is reflected on Kaylee Rae Clark's birth certificate. On May 8, 2001, a genetic test was done which indicated that Mr. Clark was not the

biological father and further designated that Kevin Griffin was the biological father.

6. The natural father, Kevin Griffin, has had no physical contact with the minor child, Kaylee Rae Clark.



Since mother's name is "Myers", Petitioner desires that the legal surname of her child be changed to "Myers" for classification purposes, to avoid confusion for the child now and in the future, and to establish a consistent and clear identity for the child. The Petitioner desires to legally change her child's name in order that she may bear the name of Kaylee Rae Myers.

8. There are no judgments or decrees of record or any other matter of like character that would be affected by granting of this Petition. This Petition is not induced by fraud or intent to cause injury or confusion.
