





COMPLAINT

AND NOW, come the Plaintiffs, Harold Hegarty and Ann Hegarty, by and through their attorneys, Evey, Rutch, Black, Dorezas, Magee & Levine LLP, and file the following Complaint:

1.

Plaintiff, Harold Hegarty, is an adult individual residing at RR1 Box 202, New Millport, Clearfield County, PA 16861-9502.

2.

Plaintiff, Ann Hegarty, is an adult individual residing at RR1 Box 202, New Millport, Clearfield County, PA 16861-9502.

3.

Defendant, Russell Wayne Glasco, is an adult individual residing at 2268 Executive Drive, Fallentimber, Cambria County, PA 16639.

4.

On or about February 17, 2001, Plaintiffs were the owners of a 2000 Toyota 4 Runner motor vehicle which was involved in the accident described herein.

5.

On that date, Defendant, Russell Wayne Glasco, was the owner of a 1988 Ford F150 pickup, which was involved in the accident described herein.

6.

On the aforesaid date, at approximately 8:57 p.m., Plaintiff, Harold Hegarty, was operating his vehicle in a careful, lawful and prudent manner on SR 0453 at its intersection with SR 0153 in Guelich Township, Clearfield County, Pennsylvania.

7.

On the aforesaid date and time, Defendant was operating his motor vehicle in a careless, reckless and negligent manner on SR 0153 at its intersection with SR 0453 in Guelich Township, Clearfield County, Pennsylvania.

8.

As the motor vehicle being operated by Defendant approached Plaintiff's vehicle, said motor vehicle, suddenly and without warning, carelessly, negligently and recklessly came into violent contact and collision with right front end/corner of the motor vehicle of the Plaintiff, causing damages as more specifically set forth below.

9.

The motor vehicle of the Plaintiff was damaged solely, directly and entirely as a result of the aforesaid collision in the amount of \$29,135.70, being the fair market value of the motor vehicle of the Plaintiff at the time of the collision.

COUNT I

PLAINTIFFS V. RUSSELL WAYNE GLASCO

10.

Paragraphs 1-9 are incorporated by reference herein as if the same had been set forth at length.

11.

The aforesaid accident was directly and proximately caused by the carelessness, recklessness and negligence of the Defendant which consisted of the following:

- a. Failing to have the motor vehicle under proper, adequate, and reasonable control under the circumstances and conditions then and there existing;
- b. Operating his motor vehicle at an excessive rate of speed under the circumstances;
- c. Operating the motor vehicle without due regard for the right, safety and position of the motor vehicle of the Plaintiffs at the time and place aforesaid;
- d. Failing to see and observe the motor vehicle of the Plaintiffs in sufficient time to avoid the damages to said motor vehicle of the Plaintiffs;
- e. Being inattentive and disregarding the condition and circumstances then and there existing;
- f. Operating a motor vehicle in such a way as to negligently and carelessly collide with the motor vehicle of the Plaintiffs;
- g. Failing to take evasive action in order to avoid impacting with Plaintiffs' vehicle;
- h. Failing to apply his brakes in sufficient time to avoid striking Plaintiffs' vehicle;

i. Failing to operate his vehicle in such a manner so as to be able to stop within the assured clear distance ahead in violation of Pa. 75 C.S.A. §3361;

j. Failing to yield the right-of-way to the vehicle driven by Plaintiff, Harold Hegary, on SR 0453 when Defendant entered and/or crossed such roadway in violation of 75 Pa. C.S.A. §3324;

m. Operating his vehicle on a highway in this Commonwealth while under the influence of a controlled substance in violation of 75 Pa.C.S.A. §3731(a);

n. Driving his vehicle with careless disregard for the safety of persons or property in violation of 75 Pa.C.S.A. §3714;

o. Failing to keep his vehicle in his lane of travel in violation of 75 Pa. C.S.A. §3309;

p. Driving a vehicle not registered to be driven as required by 75 Pa.C.S.A. §1301;

q. Driving without a valid operator's license in violation of 75 Pa.C.S.A. §1501;

r. Driving without financial responsibility as required by 75 Pa.C.S.A. § 1786;

s. Failure to yield the right-of-way as required by 75 Pa.C.S.A. §3322 - Vehicle turning left; and

t. Violating the laws and statutes of the Commonwealth of Pennsylvania pertaining to the control of speed, management, and operation of the motor vehicle in the Commonwealth.

WHEREFORE, Plaintiffs claim damages of Defendant in the amount of Twenty-Nine Thousand One Hundred Thirty-Five and 70/100 (\$29,135.70) Dollars, together with interest plus costs of suit.
