

EXHIBIT "A"

ALL that certain lot of ground situated in the Town of Loraine, in the Township of Woodward, County of Clearfield and State of Pennsylvania, bounded and described as follows:

BEGINNING at the Northwest corner of Pine Street and Fourth Street; thence running in a Northerly direction, along line of Fourth Street, one hundred fifty (150) feet to a post on Beaver Alley; thence running in a Northerly direction along the line of said Alley, sixty-one and one half (61 1/2) feet to a post; thence running in a Southerly direction, in a line parallel with the line of Fourth Street, fourteen (14) feet to a post; thence running in a Westerly direction in a line parallel with Beaver Alley, eight (8) feet to a post on line of portion of Lot No. 78; thence running in a Southerly direction in a line parallel with Fourth Street, one hundred thirty-six (136) feet to a post in line of Pine Street; thence running in an Easterly direction seventy-three and one half (73 1/2) feet to a post, the place of beginning, and being all of Lot No. 79 and a portion of Lot No. 78 in the general plan of said Village; and having thereon erected a two-story frame dwelling house and other out buildings.
