COMPLAINT

1. Plaintiff is Keith R. Cheskey whose mailing address was 406 Lochlomond Road, Philipsburg, Pennsylvania 16866.

2. Defendant is Misti Shoffner, also known as M.L. Shoffner, whose mailing address is R.R. #1, Box 453, Gearhartville, Pennsylvania 16866.

3. On June 26, 2001, Plaintiff was riding as a passenger in the rear seat of a motor vehicle being operated by Defendant.

4. On June 26, 2001, Defendant was operating her motor vehicle traveling east on Troy Hill Road/Gray Hollow Road in Morris Township, Clearfield County, Pennsylvania. For unknown reasons, Defendant traveled across the left side of the roadway, traveled off the roadway, went up an embankment and rolled the motor vehicle onto its roof, coming to rest on its roof.

5. The injuries and damages hereinafter set forth were caused solely by and were the direct and proximate result of the negligence of the Defendant in any or all of the following respects:

- a. In operating the vehicle at a high, dangerous and reckless speed under the circumstances;
- b. In failing to have the vehicle under proper control;
- c. In that the driver was inattentive and failed to maintain a sharp lookout of the road and the surrounding traffic conditions;
- d. In violating the various statutes and municipal ordinances pertaining to the operation of motor vehicles on public thoroughfares under the circumstances and particularly concerning the violation of the Pennsylvania Motor Vehicle Code, Section 3714, having been cited for careless driving;
- e. In that the driver was not in improper physical condition to drive the vehicle;
- f. In driving on the wrong side of the highway; and,
- g. In crossing the divider line which marked the center of the road.


6. Solely as a result of the negligence of the Defendant as aforesaid, Plaintiff sustained injuries which are or may be of a serious and permanent nature, including injuries to the bones, muscles, tissues and ligaments, internal injuries, shock and injury to the nerves and nervous system and other severe and serious injuries.

7. As a result of the injuries as aforesaid, Plaintiff has sustained the following damages:

- a. Said Plaintiff has suffered and will suffer great pain, suffering inconvenience, embarrassment and mental anguish;
- b. Said Plaintiff has been and will be required to expend large sums of money for surgical and medical attention, hospitalization, medical supplies, surgical appliances, medicines and attendant services;
- c. Said Plaintiff has been and will be deprived of earnings;
- d. Said Plaintiff's earning capacity has been reduced and permanently impaired; and,
- e. Said Plaintiff's general health, strength and vitality have been impaired.

WHEREFORE, Plaintiff brings this action against Defendant to recovery damages in excess of the jurisdiction of the Board of Arbitrators of this Court and in excess of Twenty Thousand Dollars (\$20,000.00).




