
It is ORDERED, DIRECTED and DECREED a judgment be



**MOTION TO COMPEL AND/OR
FOR SANCTIONS AND/OR FOR CONTEMPT**

AND NOW, comes the Plaintiffs, Daniel J. Clark, Sr. and Barbara E. Clark, husband and wife, by and through their legal counsel, Richard A. Consiglio, Esquire, and files the following Motion to Compel and/or for Sanctions and/or for Contempt:

1. That the Plaintiffs commenced this action by filing a Complaint on December 7, 1999, followed thereafter by the filing of an Amended Complaint on September 1, 2000.
2. The Plaintiffs obtained a judgment against the above named Defendant following bench trial by Order dated May 8, 2002. Notice of the entry of the Order was given to the Defendants on May 9, 2002 as required by Pa. R.C.P. 236(b).

In addition thereto said judgment was entered in the Court of Common Pleas of Clearfield County, Pennsylvania on September 3, 2002 to No. 2002-01366-CD. (A certified copy of the Statement of said Judgment entered in Clearfield County to the above number and term is attached hereto and marked Plaintiffs' Exhibit "A").

3. The Plaintiffs, by and through their legal counsel, Richard A. Consiglio, filed

and served upon Defendant's counsel Interrogatories in aid of execution on October 24, 2002. Notice of said Interrogatories was filed with the Court of Common Pleas of Blair County, Pennsylvania, and the Court of Common Pleas of Clearfield County, Pennsylvania, on the same date.

4. That the Defendant failed to answer said Interrogatories to date, and obviously has failed to answer said Interrogatories within the 30 day time period set forth in the Pennsylvania Rules of Civil Procedure.

5. The Plaintiffs believe that the Defendant has refused to file answers to said Interrogatories in an attempt to prevent the Plaintiffs from executing upon Defendant's assets in order to obtain the verdict awarded to them in this matter.

6. As a result of the Defendant's failure and/or refusal to file answers to Interrogatories, the Plaintiffs filed a Motion to Compel with the Court of Common Pleas of Blair County, Pennsylvania, on or about December 2, 2002. A copy of said Motion is attached hereto and marked Plaintiff's Exhibit "B".

Service of said Motion was had upon the counsel for the Defendant, Jeffrey S. DuBois, Esquire, by regular first class United States Mail, postage prepaid.

7. That the aforesaid Motion to Compel was heard by the Honorable Jolene Grubb Kopriva, Judge of the Court of Common Pleas of Blair County, Pennsylvania, on February 3, 2003. Both the Defendant and his counsel failed to appear for said hearing.

As a result thereof, an Order was entered on the same date of February 3, 2003 by the Court of Common Pleas of Blair County, Pennsylvania, directing the Defendant to file

answers to the aforesaid Interrogatories within 15 days from the date of said Order. Said Order also directed the Defendant to pay to counsel for the Plaintiffs the sum of \$250.00 within ten days from the date of said Order on account of counsel fees necessitated by the filing of said Motion to Compel. A certified copy of said Order is attached hereto and marked Plaintiffs' Exhibit "C".

8. That the Defendant has failed to comply with the Order of the Court of Common Pleas of Blair County, Pennsylvania, entered February 3, 2003. To date the Defendant has continued to fail to file answers to the aforesaid Interrogatories. It has also failed to pay the counsel fees ordered by the Court of Common Pleas of Blair County, Pennsylvania.

9. That the Plaintiffs believe, and therefore aver, that the Defendant is in violation of the Rules of Civil Procedure of the Commonwealth of Pennsylvania. Further, the Plaintiff believes, and therefore avers, that the Defendant is in contempt of the Order of the Court of Common Pleas of Blair County, Pennsylvania, in this matter.


WHEREFORE, the Plaintiffs pray this Honorable Court to:
