COMPLAINT IN CIVIL ACTION

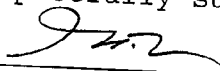
Plaintiff, FIRST CONSUMERS NATIONAL BANK, brings this action against the DEFENDANT, WANDA L KRITZER, and states the following:

1. The Plaintiff, FIRST CONSUMERS NATIONAL BANK, is located at 9300 SW Gemini Drive, Beaverton, OR 97005.
2. The Defendant, WANDA L KRITZER, is an individual residing at 514 Spruce Street, Clearfield, PA 16830.
3. 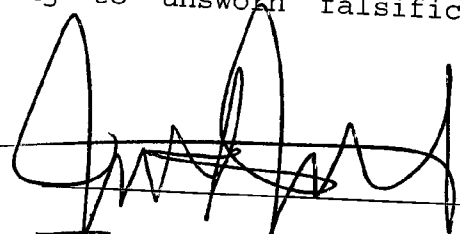

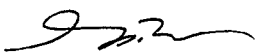

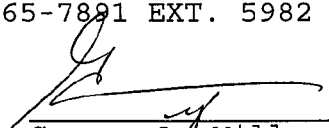
