COMPLAINT

NOW COMES, Joseph DeCasper, Plaintiff above named, and by his attorney, John R. Ryan, Esquire, and makes his Complaint against the Defendant as follows:

1. Plaintiff is Joseph DeCasper, an adult individual, residing at 1210 Daisy Street, Clearfield, Pennsylvania 16830.

2. Defendant is Paul Bloom, an adult individual, residing at Robinson Avenue, Hyde, Pennsylvania 16843.

3. On or about May 5, 2002, the Plaintiff entered into a contract with the Defendant under the terms of which Defendant was to perform certain contracting work upon the residence of the Plaintiff and would be paid a total of Five Thousand Five Hundred Dollars (\$5,500.00) by the Plaintiff for said work. The contract further called for the Plaintiff to pay the amount of Three Thousand Five Hundred (\$3,500.00) at the signing of the contract with the additional Two Thousand Dollars (\$2,000.00) to be paid on completion. A true and correct copy of the contract is attached

hereto, marked Exhibit "A" and incorporated by reference as if set forth at length.

4. The Defendant, his agents and employees, commenced work on or about June 3, 2002.

5. On or about June 24, 2002, the Defendant agreed to complete the job within an additional week and to repair certain items which he failed to do or which he did improperly.

6. The Defendant, his agents and employees, failed to perform as required under the terms of the original contract and under the terms of his additional agreements with the Plaintiff and was ordered off the job on or about June 25, 2002.

7. The Defendant failed to perform the contracted work in a workmen like fashion and as a result the Plaintiff will have to expend additional sums to have repairs made and have the work completed in a reasonable and satisfactory manner. Specifically, the Defendant failed to do the following:

- a. Install the drip edge on the roof properly;
- b. Failed to install step-flashing and counter-flashing around the flue and failed to grout the flue properly;
- c. Failed to install a ridge vent properly;
- d. Failed to install the storm shield on the main part of the roof properly;
- e. Failed to install the storm shield over the lower bathroom portion of the house properly;

f. Failed to install flashing between the back porch roof and the house;

g. Installed a gutter on the west side of the house which sags in the middle causing it to fill up with water and twist backwards;

h. Installed the down spout on the front of the house improperly;

i. Made no attempt to clean old wood and shingles off the roof and from the gutters; and,

j. Failed to trim the shingles along the drip edge around the edge of the roof.

8. As a direct and proximate result of the failure of the Defendant to properly perform the work for which he was contractually obligated to do, the Plaintiff has incurred damages in the amount of Two Thousand Seven Hundred Fifty Dollars (\$2,750.00) which will be the amount required to repair and replace the shoddy workmanship of the Defendant.

WHEREFORE, Plaintiff requests judgment be entered in his favor and against the Defendant in the amount of Two Thousand Seven Hundred Fifty Dollars (\$2,750.00), together with costs incurred at the District Justice level and costs incurred in the litigation of this action in this Court, and also together with interest thereon.


