**PRELIMINARY OBJECTIONS TO CHANGE VENUE AND BRIEF IN SUPPORT
THEREOF**

AND NOW, comes the Defendant, Megan Srock, by and through her attorneys, Thomas A. McDonnell, Esquire, and Summers, McDonnell, Walsh & Skeel, and files the following Preliminary Objections and avers as follows:

1. The Plaintiff has instituted this lawsuit against the Defendant as a result of injuries that she alleges she sustained in a motor vehicle incident occurring on or about April 8, 2000.
2. This lawsuit was filed in the Court of Common Pleas of Allegheny County, Pennsylvania; a copy of the Complaint is attached hereto as Exhibit "A".
3. The subject motor vehicle incident occurred in the Ames parking lot in Philipsburg, Clearfield County, Pennsylvania.
4. The Defendant currently resides, and at the time of the accident resided at RR #2 Box 46, Ginter, Clearfield County, Pennsylvania.
5. Rule 1006(a) of the Pennsylvania Rules of Civil Procedure provides that an action against an individual may be brought in and only in a county in which he may be served or in which the cause of action arose or where a transaction or occurrence took place out of which the cause of action arose or in any other county authorized by law.

6. As the motor vehicle incident in this case occurred in Clearfield County, Pennsylvania and the Defendant at all times relevant hereto resided in Clearfield County, Pennsylvania, the proper venue in this case is Clearfield County, Pennsylvania.

WHEREFORE, the Defendant, Megan Srock, respectfully requests this Honorable Court to grant her Preliminary Objections and order that venue of this case be transferred to Clearfield County, Pennsylvania.

BRIEF IN SUPPORT OF PRELIMINARY OBJECTIONS TO CHANGE VENUE

Statement of Facts

The Plaintiff, Amanda Coover, has filed the present lawsuit in the Court of Common Pleas of Allegheny County, Pennsylvania against the Defendant, Megan Srock, as the result of injuries that the Plaintiff alleges to have sustained in a motor vehicle incident occurring on or about April 8, 2000. The subject motor vehicle incident occurred in the Ames parking lot in Philipsburg, Clearfield County, Pennsylvania. The Defendant now resides, and at the time of this incident, resided at RR # 2 Box 46, Ginter, Clearfield County, Pennsylvania. The Defendant avers that venue is improper in this matter.


DISCUSSION

COMPLAINT

1. The plaintiff resides at 19 East 10th Street, Tyrone, Blair County, Pennsylvania.
2. The defendant resides at RR#2 Box 46, Ginter, Clearfield County, Pennsylvania.
3. The events complained of happened on April 8, 2000 in Philipsburg, Pennsylvania.
4. At that time and place the plaintiff was a passenger in a motor vehicle in the Ames parking lot when the defendant negligently backed her vehicle out of a parking space and collided with the vehicle in which the plaintiff was riding, thereby injuring the plaintiff.

5. The injuries and damages suffered by the plaintiff were the direct and proximate result of the negligence of the defendant in the following respects:

- (a) in operating her vehicle at an excessive rate of speed under the circumstances;
- (b) in failing to keep and maintain a proper and adequate lookout;
- (c) in failing to keep and maintain her vehicle under proper and adequate control;

- (d) in failing to yield the right of way to the said plaintiff's vehicle which was entitled thereto under the circumstances;
- (e) in failing to stop, slow or turn the said defendant's vehicle aside when the defendant knew or by the exercise of reasonable care should have known that if the said vehicle were permitted to proceed a collision would result;
- (f) in operating the said defendant's vehicle into collision with the said automobile of the plaintiff;
- (g) in failing to properly observe and heed the traffic conditions then and there existing;
- (h) in accelerating the said defendant's vehicle under the circumstances.


6. As a direct and proximate result of the negligence of the defendant, the plaintiff suffered strain, sprain, injury and damage to the muscles, ligaments nerves and tissues of the cervical, thoracic and lumbar spine, including the cervical brachial plexus.

7. As a direct and proximate result of the negligence of the defendant the plaintiff has been damaged as follows:

- (a) she has incurred and may in the future incur medical expense for the treatment of her injuries;
- (b) she has suffered and may in the future suffer pain, inconvenience, mental distress and loss of enjoyment of life.

WHEREFORE, the plaintiff demands judgment against the defendant for an amount in excess of the arbitration limits of this court.

PLAINTIFF'S ARBITRATION PRE-TRIAL STATEMENT

Statement of the Case

This is an action requesting money damages as compensation for injuries suffered as a result of an automobile accident that happened April 8, 2000 in Philipsburg, Pennsylvania. The plaintiff was a passenger in a motor vehicle operated by Tracy Yarger in the Ames parking lot when the defendant negligently backed her vehicle out of a parking space and collided with the Yarger vehicle on the driver's side, thereby injuring the plaintiff. As a result of the collision the plaintiff suffered strain, sprain, injury and damage to the muscles, ligaments nerves and tissues of the cervical, thoracic and lumbar spine, including the cervical brachial plexus.

Applicable Case or Statutes

The plaintiff's claim is based upon principles of common law negligence.






