


## COMPLAINT

Now comes the plaintiff, Robert Thomas Freeland who hereby avers as follows:

1. Robert Thomas Freeland is an adult individual, whose address is 111 Lochlomond Rd. Philipsburg, PA 16866.
2. Defendant is Valley Tire Co. / Dan Farley, is an adult individual, whose address is Valley Tire Co. 1583 Philipsburg – Bigler Highway, Philipsburg, PA 16866.
3. On June 5, 2002 the plaintiff had his 1993 Ford F150 4X4 pickup truck towed to Valley Tire Co.. Sundance Auto Sales located in Sandy Ridge, PA told him to take the truck there, since he had a warranty on the truck through W.P.C.. The defendant was then authorized to replace the starter. After they replaced the starter, they started ripping parts off of the motor

and lost some of the parts. They did this without authorization from the warranty company. The store manager, Dan Farley (Defendant) gave authorization for his employees to do this and never called the Plaintiff or the Warranty Co.

4. Valley Tire Co. ordered a rental car for the Plaintiff, because they messed up the truck. The Plaintiff needed a vehicle for his doctor's appointment and for any emergencies due to him being disabled and on social security.
5. The Plaintiff's truck was at Valley Tire Co. for 7 days without any progress being done. An inspector came from the Warranty Co. and he said that there was no need for the Plaintiff's truck to be torn apart and down for 7 days. He also stated that the only authorization that was given from the Warranty Co. was for the new starter.
6. After 7 days on June 12, 2002, the Plaintiff had his truck towed from Valley Tire Co. to Scott Ford Inc. garage. The bill at Scott Ford Inc was \$281.50. The Plaintiff paid \$281.50 to get his truck put back together, which he never authorized to have done.
7. The Plaintiff sued Valley Tire Co. for the bill at Scott Ford Inc. and the court fees, which was a total of \$ 325.50.
8. The Plaintiff won the judgment for \$325.50. The Defendant; Valley Tire Co. was then given 30 days to pay the Plaintiff. Instead of paying the Plaintiff the \$325.50, the Defendant told the District Magistrate (Mike Rudella) that he was only paying the Plaintiff \$175.50 and that he took \$150.00 out of the judgment money to pay the car rental (Enterprise) bill. However, the bill at Enterprise was paid on August 24, 2002, which was before the hearing on September 16, 2002. The Defendant; Dan Farley failed to mention that the bill for Enterprise had been paid.
9. The Plaintiff won the judgment of \$281.50 for the bill from Tom Scott Ford repairs and \$44.00 for the court cost.
10. The Plaintiff wants the \$150.00 plus \$80.00 for the filing fee, which he feels he deserves, plus interest and such other reasonable cost as the court may allow.


