1. Your Petitioner is Erin McCoy Ager, residing at PO Box 154, Nicktown, PA 15762.
2. Your Petitioner is the Natural Mother of Molly Paige Kane, D.O.B. February 2, 1995, age 7 (Minor Child).
3. The Natural Father of the Minor Child is unknown as evidenced by the Minor Child's birth certificate (Attachment "A").
4. The Natural Mother and the unknown Natural Father of the minor child were never married, and the Minor Child was born out of wedlock.
5. The Natural Mother of the Minor Child is currently married to Eric F. Ager.

8. Your Petitioner believes the best interest of the Minor Child would be served by the Minor Child adopting the last name of Your Petitioner and Your Petitioner's husband.


