C O M P L A I N T

NOW COMES the Plaintiff, JOANNE R. DUTTRY, and by her attorney, James A. Naddeo, Esquire, sets forth the following:

1. That the Plaintiff is Joanne R. Duttry, an adult individual, who resides at 2797 Windy Hill Road, Curwensville, Pennsylvania 16833.
2. That Defendant is Martin R. Duttry, an adult individual, who resides at RD1 Box 17, Olanta, Pennsylvania 16863.
3. That Defendant is Catherine A. Duttry, an adult individual, who resides in Smokerun, Pennsylvania 16681.
4. Plaintiff and Defendants are the owners of certain real estate in Knox Township, Clearfield County, Pennsylvania, as described below, and all interests of the parties in the property are held as tenants in common and are undivided.

5. The parties acquired title to the property known as 13 acres 102.7 perches, more or less, and 10 acres, more or less, respectively, by Deed dated October 30, 1984, and recorded in the Office of the Recorder of Deeds of Clearfield County in Volume 979, Page 208, wherein said Pauline Amelia Lowell conveyed all those two parcels of land situate in the Township of Knox, Clearfield County, Pennsylvania, bound and described as follows:

THE FIRST THEREOF, beginning at a hemlock, thence by land of Jno. McCullough N 54° E 95 perches to white oak; thence N 40° W 18 perches to a post; thence by land of Margaret B. Lord S 60° W 97 perches to a hemlock; thence by land of Isabella McKee S 4° E 32 perches to place of beginning. CONTAINING: 13 acres 102.7 perches more or less.

6. No person other than the parties to this suit has any interest in the property which is presently in the possession of Defendant Martin R. Duttry.


7. No partition or division of the property has ever been made, although Plaintiff has requested the Defendants to join with her in making one as appears from the letter attached hereto as Exhibit "A".

I have been consulted by Joanne Duttry concerning her interest in a 23 +/- acre parcel of land located in Knox Township, Clearfield County.

I am enclosing a copy of the Deed from Pauline Amelia Lowell to Martin Ray Duttry and Catherine Annett Duttry dated October 30, 1984, recorded in Volume 979, Page 208. I am also enclosing a copy of the later Deed from Martin and Catherine to Joanne Duttry.

It is my understanding that the subject property is part of the focus of domestic litigation between Martin Ray Duttry and Catherine Annett Duttry. My client would like to have the co-tenancy dissolved. I propose that we effect an amicable dissolution of the co-tenancy. I suggest that we have the property appraised by someone with whom all parties have a comfort level. I would then recommend that the property be placed on the market for the appraised value. When the property is sold, distribution of the proceeds would then be

5. That Defendant, Martin R. Duttry, was properly served with Notice of Default on December 27, 2002.






