## COMPLAINT

AND NOW, comes the plaintiff, Robert V. Dubler, by and through his attorneys, Meyer, Darragh, Buckler, Bebenek & Eck, P.L.L.C., and files the following complaint in civil action against the defendant, Dennis R. Lauver, Jr., and in support thereof, avers as follows:

1. Plaintiff, Robert V. Dubler, is an adult individual residing at 21518 Tithables Circle, Ashburn, Virginia 20148.
2. Defendant, Dennis R. Lauver, Jr., is an adult individual who, upon information and belief, resides in Coalport, Pennsylvania 16627.
3. The events upon which this complaint are based occurred on September 14, 2001 in the parking lot of the CSB Bank in Coalport, Pennsylvania.
4. On September 14, 2001, plaintiff was the owner of a 1999 Pontiac Sunfire vehicle, which, at all times material, was lawfully being driven by plaintiff in the CSB Bank parking lot in Coalport, Pennsylvania.
5. On September 14, 2001, defendant was operating a 1986 Oldsmobile vehicle in the CSB Bank parking lot in Coalport, Pennsylvania, when he carelessly, negligently and recklessly backed out from a parking space and caused his vehicle to collide with plaintiff's vehicle causing plaintiff to sustain damages as more fully set forth herein.
6. The aforesaid acts of defendant were negligent in one or more of the following:

- (a) driving at an excessive rate of speed;
- (b) failing to apply his brakes in a timely fashion so as to avoid contact with plaintiff's vehicle;
- (c) failing to take timely and appropriate evasive action so as to avoid colliding with plaintiff's vehicle;
- (d) allowing his vehicle to collide with plaintiff's vehicle;
- (e) failing to keep his vehicle under proper control;
- (f) failing to observe with reasonable care the traffic and road conditions, including the location of plaintiff's vehicle;
- (g) in operating his vehicle in a negligent, careless and reckless manner at all times causing said vehicle to collide with plaintiff's vehicle;
- (i) in operating a vehicle without a valid drivers license;
- (j) in operating a vehicle without proper insurance;
- (k) in failing to give plaintiff the right-of-way; and
- (l) in operating his vehicle in violation of the Pennsylvania Motor Vehicle Act.

7. The negligent, careless and reckless conduct of defendant was the legal and proximate cause of the September 14, 2001 accident resulting in damages to plaintiff's vehicle as set forth herein.

8. As a direct and proximate result of the negligence of defendant, as hereinabove set forth, the plaintiff sustained property damage to his vehicle in the amount of \$1,530.33.

9. Pursuant to Pa.R.Civ.P. 1305, attached please find a copy of the estimate produced by Condren Oldsmobile Cadillac, Inc., estimating the amount of damages to plaintiff's vehicle at \$1,530.33 which includes plaintiff's deductible of \$500.00.

WHEREFORE, plaintiff, Robert V. Dubler, respectfully prays that judgment be entered against the defendant, Dennis R. Lauver, Jr., in the amount of \$1,530.33, an amount less than the arbitration limits set by the Pennsylvania Rules of Civil Procedure, together with pre and post-judgment interest thereon at the statutory rate, attorneys' fees and costs and for such other relief as the court deems appropriate.
