1. Plaintiff is a corporation having offices at 6575 Snowdrift Road, Suite 101, Allentown, PA 18106.

2. Defendant is an individual whose address is 203 Tozier Avenue, DuBois, Clearfield County, PA 15801.

3. On or about January 3, 2001 the Defendant was operating a motor vehicle on E. Scribner Avenue in DuBois Pennsylvania.

4. Defendant negligently operating his vehicle at the time and failing to exercise due care under the conditions failed to stop at the intersection and struck at vehicle which was being lawfully and carefully operated by Plaintiff's insured, Patrick McHugh.

5. The Plaintiff subsequently paid its insured an insurance claim in the amount of \$3,101.59.

6. The Plaintiff is entitled to be subrogated to all of the rights and claims of its insured arising from said incident.
