**DECLARATION OF TAKING**

AND NOW, comes the Sewer Authority of the Township of  
Huston, and files the following Declaration of Taking:

1. The Condemnor is the Sewer Authority of the Township of  
Huston, located along Route 255, Penfield, Pennsylvania, with a  
mailing address of P. O. Box 121, Penfield, Pennsylvania, 15849.

2. The interest in the property hereinafter described  
condemned in fee simple where absolute title by the Condemnor for  
the purposes of laying sewer lines, pursuant to the act of the Sewer  
Authority of Huston Township, as authorized by resolution of the  
Huston Township Sewer Authority dated and adopted December 10,  
2002. A copy of the resolution is attached hereto and made a part  
hereof as Exhibit "A". The original of the resolution may be examined  
at the offices of the Condemnor at the above address.

3. The purpose of the condemnation is to acquire property  
interest for the construction, operation, and maintenance of a sewer  
system and related facilities to be constructed, operated and  
maintained by the Authority in Huston Township.


4. The description of the properties condemned sufficient for its identification is set forth herein and attached hereto and made a part hereof as Exhibit "B". On the same day as this Declaration of Taking being filed with the Prothonotary, plans showing the property condemned are being lodged for record in the Office of the Recorder of Deeds of Clearfield County, Pennsylvania, in accordance with Section 404 of the Eminent Domain Code, 26 Pa.Stat.Ann. 1-404.

5. The nature of the title acquired in and to the property is as described in Paragraph 4 hereof is a permanent and sufficient easement, right-of-way, rights, and privileges for the purpose of placing, constructing, operating, repairing, maintaining, rebuilding, replacing, relocating, and removing sewer facilities over, across, and upon and through the easement area as shown on the plats, with the right to use so much of the surface of the property as may be reasonable necessary to construct and install within the easement and right-of-way the facilities to be constructed as well as the right to ingress and egress over the property for maintenance of the facilities within the easement and right-of-way condemned.


6. A plan showing the condemned property may be inspected during regular business hours at the address of the Condemnor.

### **RESOLUTION OF CONDEMNATION**

A RESOLUTION OF CONDEMNATION AUTHORIZING THE SELECTION AND APPROPRIATION OF AREAS WITHIN HUSTON TOWNSHIP, AND AUTHORIZING THE FILING OF A DECLARATION OF TAKING AND ALL NECESSARY ACTION FOR THE ACQUISITION THEREOF.

**WHEREAS**, the Huston Township Sewer Authority, hereinafter referred to as the "Authority", is a valid body corporate and politic, organizing and existing under the laws of the Commonwealth of Pennsylvania, and formed to undertake the acquisition and construction of the sanitary sewer system; and

**WHEREAS**, the Authority has entered into a contract for the construction of a sanitary sewer system within the Township; and

**WHEREAS**, in order to carry out the aforementioned project, it is necessary for the respective contractors to lay sewer lines within the Township and across various landowners; and

**WHEREAS**, to accomplish these objectives, it is necessary that the Authority acquire title in fee simple to the lands, improvements, and properties included in the area of the Township where the system will be placed; and

**WHEREAS**, the Authority has been unable to agree with some of the owners of the properties to be acquired, both as to permission as well as the price or damages to be paid; and

**WHEREAS**, in accordance with the Pennsylvania Eminent Domain Code, as amended, the Authority is authorized to acquire title to the properties through Eminent Domain proceedings.

**NOW, THEREFORE, BE IT RESOLVED**, that the Huston Township Sewer Authority, in accordance with the authority conferred to it by law, selects and appropriates for purposes of the sanitary sewer system project, various properties within Huston Township, and more fully described in Exhibit "A" herein.

**RESOLVED**, that all title and private rights or easements of whatever nature of property owners to beds of unopened streets

located within the area are hereby selected and appropriated for the purpose of the Authority, in accordance with law.

**RESOLVED**, that the title to be acquired shall be absolute or fee simple of title, including all easements, rights of way, and real property interest of whatever nature.

**RESOLVED**, that counsel for the Authority and its proper officers are hereby authorized to file a Declaration of Taking and such other proceedings as is necessary, including the entry of such bond as may be necessary and desirable, to carry out the purpose of this resolution.

**RESOLVED**, that the institution of such proceedings, and any damages which may be agreed upon or awarded to any party interest, including the owner or owners of the said properties located within this area, shall be paid out of the funds of the Authority.

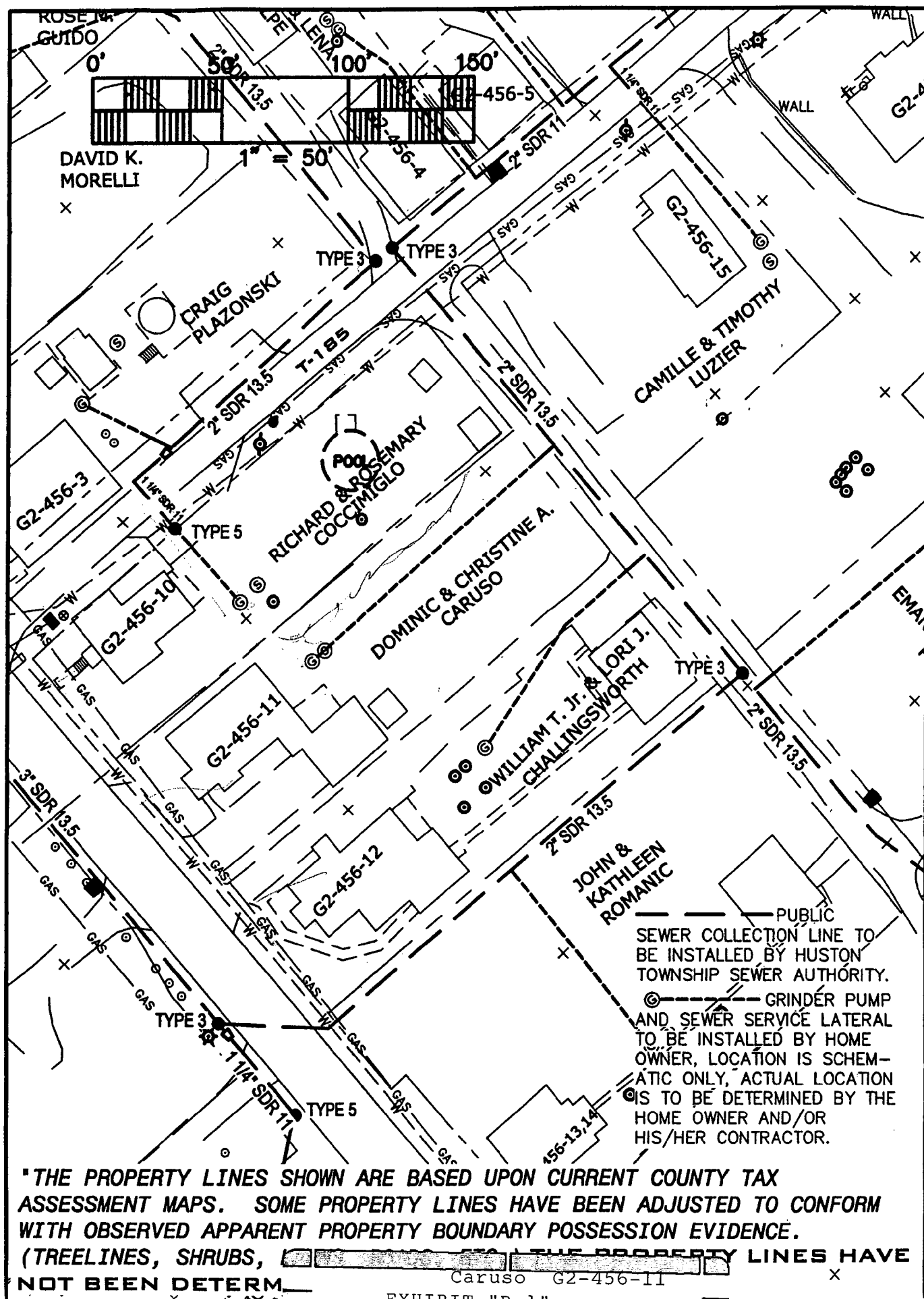
