

COMPLAINT

NOW COMES Plaintiff, Precision Dimension, by and through its attorneys, Delafield, McGee, Jones & Kauffman, L.L.P., and makes the following Complaint upon Defendant:

1. Plaintiff is Precision Dimension (hereafter "Plaintiff"), a partnership, with principal offices at 1423 Burley Avenue, Tyrone, Blair County, Pennsylvania (16686).
2. Defendant is Tri-Woods, Inc. (hereafter "Defendant"), a Pennsylvania corporation, with offices at 329 Aspen Way, DuBois, Clearfield County, Pennsylvania (15801).
3. At all times relevant to this action, Plaintiff was engaged in the business of the preparation and sale of wood-related products.
4. At the instance and request of Defendant, Plaintiff, at various times, supplied to Defendant both surfacing and gang-rip materials, as more fully set forth in the invoices attached hereto, incorporated herein, and marked Exhibits "A-1" through "A-10", inclusive, and Defendant agreed to pay Plaintiff for those supplies and materials.

5. The balance that is due to Plaintiff and which Defendant agreed to pay to Plaintiff is the total sum of Ten Thousand Eight Hundred Seventy-seven and 20/100 (\$10,877.20) Dollars, as detailed on Plaintiff's Exhibits "A-1" through "A-10", inclusive, attached hereto.

6. Plaintiff has fulfilled all terms and conditions of, and completed all performance required of Plaintiff pursuant to the agreement between the parties.

7. Despite demand by Plaintiff, Defendant has failed and refused and continues to fail and refuse to pay all or any portion of the balance due.

WHEREFORE, Plaintiff, Precision Dimension, respectfully demands judgment in its favor and against Defendant, Tri-Woods, Inc., in the amount of Ten Thousand Eight Hundred Seventy-seven and 20/100 (\$10,877.20) Dollars, together with costs of suit and interest thereon.
