PETITION TO TRANSFER STRUCTURED SETTLEMENT

AND NOW, comes Petitioner, Carl Gordon, by and through his attorneys, The Hopkins Law Firm, and files the within Petition and in support thereof states as follows:

1. Petitioner is Carl Gordon whose address is 111 Sixth Street, P.O. Box 151 Stump Creek, Pennsylvania 15863.
2. Petitioner was involved in a motor vehicle accident in 1990 and suffered personal injuries primarily to his back and legs. Petitioner was represented by an attorney in a personal injury action that followed and as a result thereof, received a settlement in which Petitioner received \$120,000.00 in cash in a structured settlement consisting of an annuity paying \$596.62 each month for the remainder of his life with a guarantee of 20 years worth of payments.
