C O M P L A I N T

NOW COMES the Plaintiffs, DAVID W. REED and TINA M. REED, and by their attorney, James A. Naddeo, Esquire, set forth the following:

1. That the Plaintiffs are David W. Reed and Tina M. Reed, husband and wife, who reside at 203 Turkey Hill Road, Olanta, Pennsylvania 16863.

2. That the Defendant is Lynn Bunnell, an adult individual, who resides at RR1 Box 110, Olanta, Pennsylvania 16863.

COUNT I

3. That at all times referred to herein, Plaintiffs were the owners of property located in the Borough of Clearfield identified as 304 Park Avenue, Clearfield, Pennsylvania.

4. That the premises described in Paragraph 3 hereof contained two (2) residential second floor apartments known as 304A and 304B respectively.

5. That on or about January 1, 2002, Plaintiffs entered into an oral month-to-month lease with Defendant for apartment 304B.

6. That pursuant to the terms of the month-to-month tenancy referred to in Paragraph 5 hereof, Defendant was to pay to Plaintiffs the sum of \$335.00 per month.

7. That Defendant took possession of Plaintiffs' apartment known as 304B on or about January 1, 2002.

8. That Defendant paid rent in the amount of \$335.00 per month for the months of January, February, March and April 2002.

9. That commencing in May 2002, Defendant failed to pay the rent owed to Plaintiffs and persisted in that failure until the middle part of December 2002 when Defendant, without notice to Plaintiffs, vacated the premises.

10. That at the time Defendant vacated the premises, Defendant had failed to pay rent due to Plaintiffs commencing in May 2002 to December 2002 in the total amount of \$2,680.00 or \$335.00 per month.

11. That Plaintiffs have made demand upon Defendant to pay the rent owed, but Defendant has failed and/or refused to pay.

WHEREFORE, Plaintiffs demand judgment against Defendant in the amount of \$2,680.00 with interest thereon as allowable by law.

COUNT II

12. Plaintiffs incorporate Paragraphs 3 through 12 of their Complaint by reference and make them a part hereof.

13. That Defendant vacated Plaintiffs' premises without notice to Plaintiffs during the middle of December 2002.

14. That during the time Defendant occupied Plaintiffs' premises Defendant damaged the stove in the apartment to the extent that it had to be replaced at a cost to Plaintiffs in the amount of \$314.82.

15. That when Defendant vacated Plaintiffs' premises, she left the property in a serious state of uncleanliness and disrepair.

16. That Plaintiffs were required to expend the sum of \$275.00 to clean their property and to haul away refuse left on the premises by Defendant.


17. That when Defendant vacated Plaintiffs' premises, she failed to fill the oil tank servicing the apartment occupied by Defendant as required by the terms of the parties' oral lease agreement.

18. That Plaintiffs were required to expend the sum of \$225.00 to fill the oil tank left empty by the Defendant.

19. That Plaintiffs have made demand upon Defendant to reimburse them for the stove, cleaning charges and fuel charges incurred by Plaintiffs, but Defendant has failed and/or refused to pay.

WHEREFORE, Plaintiffs claim damages in the amount of \$814.82 with interest thereon as allowable by law.
