COMES NOW, Plaintiff, Denette A. Douthit, by her counsel, Katz, Cohen & Price, P.C. and desiring to recover compensation for the injuries, losses and damages sustained by her as a result of the negligence and carelessness of the Defendants avers in support thereof the following:

1. Plaintiff, Denette A. Douthit is an adult individual who is a citizen and resident

of the Commonwealth of Pennsylvania residing therein at 928 E. Main Street, Reynoldsville, Clearfield County.

2. Defendant, Jennifer Wineberg-Zeitler, M.D. is a licensed professional with offices in Clearfield County, Pennsylvania. Plaintiff is asserting professional liability against this Defendant.

3. Defendant, DuBois Regional Medical Center is a licensed professional with offices in Clearfield County, Pennsylvania. Plaintiff is asserting professional liability against this Defendant.

4. Defendant, George Palmer, Jr., M.D. is a licensed professional with offices in Clearfield County, Pennsylvania. Plaintiff is asserting professional liability against this Defendant.

5. Defendant, Russell E. Cameron, M.D. is a licensed professional with offices in Clearfield County, Pennsylvania. Plaintiff is asserting professional liability against this Defendant.

6. Defendant, Jennifer Wineberg-Zeitler, M.D., at the time of the occurrence, held herself out as a licensed practitioner providing medical care and purporting to specialize in family medicine with an office at 5 North Third Street, Reynoldsville, Clearfield County, Pennsylvania.

7. Defendant, DuBois Regional Medical Center is, upon information and belief, a corporation organized and existing under the laws of the Commonwealth of Pennsylvania regularly conducting business at 100 Hospital Avenue, DuBois, Clearfield County, and engaged in the business of providing health care services to the public.

8. Defendant, George Palmer, Jr., M.D., at the time of the occurrence, held himself

out as a licensed practitioner providing medical care and purporting to specialize in emergency medicine with an office at 100 Hospital Avenue, DuBois, Clearfield County, Pennsylvania.

9. Defendant, Russell E. Cameron, M.D., at the time of the occurrence, held himself out as a licensed practitioner providing medical care and purporting to specialize in emergency medicine with an office at 100 Hospital Avenue, DuBois, Clearfield County, Pennsylvania.

10. At all times material hereto, Defendant, DuBois Regional Medical Center acted by and through its authorized agents, servants, workmen and/or employees including, Defendants, George Palmer, Jr., M.D. and Russell E. Cameron, M.D. as well as each and every health care professional who saw Plaintiff professionally during the various visits to DuBois Regional Medical Center made by Plaintiff as further described in this Complaint.

11. Prior to March 16, 2001, Plaintiff, Denette A. Douthit began to feel ill.

12. Several days later, on March 16, 2001, Defendant, Jennifer Wineberg-Zeitler prescribed Brontex for Plaintiff and telephoned a prescription to a pharmacy without examining Plaintiff.

13. Defendant, Jennifer Wineberg-Zeitler was aware that Plaintiff had a history of sarcoidosis.

14. On March 18, 2001, Plaintiff went to the emergency room of Defendant, DuBois Regional Medical Center where she was seen by Defendant, Russell E. Cameron, M.D.

15. At that time, Plaintiff related that she was suffering from "really bad headaches", pressure to the frontal area and base of the head, that she was experiencing chills and had a fever of 100.9 degrees Fahrenheit, that she did not have a sore throat, that her ears were pounding, that her neck felt stiff and that these symptoms had started the previous Thursday afternoon,

March 16, 2001.

16. Defendant, Russell E. Cameron, M.D. was informed that Plaintiff, Denette A. Douthit had a history of sarcoidosis.

17. At the time of her examination on March 18, 2001, Plaintiff reported that her headache level at its worst was 10/10 and at the time she was seen by Defendant, Russell E. Cameron, M.D. on March 18, 2001, her pain level was 9/10.

18. At the time of her examination by Defendant, Russell E. Cameron, M.D. on March 18, 2001, Plaintiff reported that her vision was disturbed and that she had dizziness.

19. Following his examination, Defendant, Russell E. Cameron, M.D. on March 18, 2001 diagnosed Plaintiff as having sinusitis and prescribed Cefitin 500 mg twice a day.

20. Plaintiff telephoned Defendant, Jennifer Wineberg-Zeitler, M.D. every two or three days between March 18, 2001 and March 29, 2001.

21. On March 29, 2001, Plaintiff was seen by Defendant, Jennifer Wineberg-Zeitler, M.D. and informed her that she was only sleeping two or three hours per night, she had an occipital headache that was throbbing, that she was light headed, that sounds were muffled, that she had nausea without vomiting, that she had photophobia and phonophobia and occasional blurred vision.

22. Plaintiff indicated at the time of the March 29, 2001 examination by Defendant, Jennifer Wineberg-Zeitler, M.D. that she had tried Flexoril but it did not provide relief.

23. On March 31, 2001, Plaintiff returned to the DuBois Regional Medical Center emergency room where she was seen by Defendant, George Palmer, Jr., M.D. At the time, Plaintiff gave her history, she related she had suffered previously from sarcoidosis.

24. At the time she was seen by Defendant, George Palmer, Jr., M.D. on March 31, 2001, she indicated that she had been suffering from a headache for sixteen days which she characterized as throbbing, nausea, vomiting, blurred vision, muscle aches and cough.

25. Plaintiff reported a pain level of 10/10 and sensitivity to light.

26. Following Dr. Palmer's examination, Plaintiff was discharged.

27. On April 2, 2001, Plaintiff telephoned the office of Defendant, Jennifer Wineberg-Zeitler, M.D. complaining of neck pain at which time she was instructed to have a physical therapy evaluation.

28. On April 5, 2001, Plaintiff again telephoned the office of Defendant, Jennifer Wineberg-Zeitler, M.D. complaining of headaches and neck pain at which time Defendant, Jennifer Wineberg-Zeitler scheduled an MRI for April 10, 2001.

29. On April 9, 2001, Plaintiff again telephoned the office of Defendant, Jennifer Wineberg-Zeitler, M.D. complaining of pain in the shoulder, neck and head as well as double vision.

30. On April 10, 2001, Plaintiff went to DuBois Regional Medical Center where she received a spinal tap and was diagnosed as having cryptococcal meningitis after receiving a spinal tap.

COUNT I

- (b) In failing to properly diagnose Plaintiff cryptococcal meningitis;
- (c) In failing to order a spinal tap;
- (d) In failing to properly take into account Plaintiff's history of sarcoidosis;
- (e) In failing to timely order a lumbar puncture;
- (f) In failing to inform Plaintiff of warning signs of cryptococcal meningitis;

34. As a direct and proximate result of the conduct set forth, Plaintiff has suffered as follows:







ANSWER AND NEW MATTER

NOW COMES, DuBois Regional Medical Center, George Palmer, Jr., D.O., Russell E. Cameron, M.D., three of the defendants, by their attorneys, Thomson, Rhodes & Cowie, P.C., and file the following answer and new matter in response to plaintiff's complaint.

ANSWER

1. Defendants are advised and therefore believe and aver that the Pennsylvania Rules of Civil Procedure do not require them to set forth their answers and defenses except as stated below.

2. If and to the extent that any factual averment in the complaint is not responded to in the paragraphs which follow, said allegation is denied for the reason that, after a reasonable investigation, these defendants lack sufficient information or knowledge upon which to form a belief as to the truth of the averments therein.

3. Each of the paragraphs of this answer should be read so as to incorporate by reference each of the other paragraphs of this answer.

4. The following paragraphs of the complaint are denied for the reason that, after a reasonable investigation, these defendants have insufficient information or

knowledge to form a belief as to the truth of the averments therein: 1, 11, 12, 13, 20, 21, 22, 27, 28, 29.

5. The following paragraphs of the complaint refer solely to other defendants for which reason no response is required: 2, 6, 32.

6. Paragraph 3 of the complaint is admitted in part and denied in part. The first sentence is admitted. With regard to the second sentence it is admitted that plaintiff is making the allegations specified. However, any statement, suggestion or implication that these allegations have merit is denied.

7. Paragraphs 4 and 5 of the complaint are denied as stated. Drs. Palmer and Cameron are emergency room physicians at DuBois Regional Medical Center. It is admitted that plaintiff is asserting a professional liability action, however, any statement, suggestion or implication that the action has any merit whatsoever is denied.

8. Paragraph 7 of the complaint is denied as stated. To the contrary, defendant is a non-profit healthcare institution located at the address specified in the complaint.

9. The following paragraphs of the complaint are admitted: 8, 9, 14, 16, 19, 36, 37, 42.

10. Paragraph 10 of the complaint is denied for the reason that, after a reasonable investigation, these defendants have insufficient information or knowledge to form a belief as to the truth of the averments therein, because the identity of the alleged agents, servants and/or employees of these defendants is not specified or disclosed, except with regard to Drs. Palmer and Cameron. As to Drs. Cameron and Palmer, agency is admitted.

11. Paragraphs 15, 17, 18, 23, 24, 25 and 26 of the complaint are denied for the reason that they incompletely, inaccurately and/or misleadingly describe events which occurred. While these paragraphs to some extent extract or reference words or phrases from the medical records, they do not reflect the context in which the notes were made and they ignore other words and phrases necessary to give fair meaning to the referenced language.

12. Paragraphs 31, 35, 41 of the complaint solely incorporate by reference other paragraphs, for which no separate response is required. However, to the extent that any additional response is deemed necessary, defendants incorporate by reference their answers to those paragraphs which have been incorporated by the plaintiff.

13. Paragraphs 33 (including sub-paragraphs (a) through (f)) and 34 (including sub-paragraphs (a) through (f)), pertain to another defendant, for which reason no response is required. However, if any response is deemed necessary, these paragraphs and sub-paragraphs are denied for the reason that, after a reasonable investigation, this

defendant has insufficient information or knowledge to form a belief as to the truth of the averments therein.

14. Paragraph 38 of the complaint constitutes a conclusion of law to which no further response is required.

15. Paragraphs 39 (including sub-paragraphs (a) through (f)), 40 (including sub-paragraphs (a) through (f)), 43 (including sub-paragraphs (a) through (f)), 44 (including sub-paragraphs (a) through (f)) of the complaint constitute conclusions of law to which no further response is required. However, if any response is deemed necessary, these paragraphs and sub-paragraphs are denied.

WHEREFORE, plaintiff's complaint should be dismissed and judgment should be entered in favor of these defendants.

NEW MATTER

16. In the absence of a special contract in writing, a healthcare provider is neither a warrantor nor a guarantor of a cure. This provision is pleaded as an affirmative defense insofar as there was no special contract in writing in this case.

17. These defendants plead the applicability of the Pennsylvania Comparative Negligence Statute as an affirmative defense.

18. While denying all negligence and all liability, these defendants aver that if they are found to have been negligent in any respect, any liability resulting therefrom would be diminished or barred by operation of the Pennsylvania Comparative Negligence Statute.

19. Plaintiff's complaint fails to state any cause of action against these defendants.

20. Defendants plead the doctrines of intervening and superseding causes as affirmative defenses.

21. Defendants plead "payment" as an affirmative defense to the extent that any amount less than the amount billed for medical services to the plaintiff after the alleged incident was accepted as payment in full.

22. Defendants are not liable for any pre-existing medical conditions which caused the claimed injuries and/or damages.

23. To the extent that evidence develops during discovery to demonstrate the application of the two schools of thought doctrine, defendants plead that doctrine as providing a complete defense for any alleged negligence and/or malpractice.

24. These defendants raise all affirmative defenses set forth or available as a result of the provisions of House Bill 1802 which became Pennsylvania law in 2002.

25. To the extent plaintiffs base their claim in whole or in part on any act occurring more than two years prior to the filing of the lawsuit, the claims are barred by the applicable statute of limitations, which is pleaded as an affirmative defense.

26. Defendants plead all applicable statutes of limitations as affirmative defenses.


27. If and to the extent that plaintiff's claims were not filed within the time limitations imposed by law, said lawsuit is barred by the applicable statutes of limitations.

PURSUANT TO PENNSYLVANIA RULE OF CIVIL PROCEDURE 1042.26

COMES NOW, Plaintiff Denette Douthit by her counsel, Katz, Cohen & Price, and desiring to have the Court enter an ORDER establishing Case Management Deadlines in accordance with Pennsylvania Rule of Civil Procedure 1042.26 avers in support thereof the following:

1. The within matter involves a claim for personal injuries sustained as a result of alleged professional medical negligence.
2. On or about April 23, 2004, counsel for Defendants George Palmer Jr., Russell E. Cameron, M.D. and DuBois Regional Medical Center forwarded a request to

Plaintiff for Production of Expert Reports. A true and correct copy of this transmittal letter is attached hereto made part hereof and marked Exhibit "1". A true and correct copy of the Request is attached hereto made part hereof and marked Exhibit "2".

3. Counsel for Defendant Jennifer Wineberg- Zeitler has filed a similar request to Plaintiff for Production of expert reports, however, said counsel has agreed to a reasonable extension of time for the response to the request to Plaintiff for Production of Expert Reports.

4. Immediately upon receipt of the Request for the production of Documents, Counsel for Plaintiff attempted to schedule the depositions of the various Defendants in this matter in an effort to comply with the 180 day time limit.







Defendant Jennifer Wineberg-Zeitler was the Plaintiff's family physician at the time of the incident and Defendants Palmer and Cameron saw Plaintiff in the emergency room of Defendants DuBois Regional Medical Center. The principal allegations of negligence against the various Defendants is a failure to promptly and properly diagnose the Plaintiff's medical condition, meningitis.

On April 23, 2004, counsel for Defendants forwarded to counsel a Request for

Production of Expert Reports in accordance with Pennsylvania Rule Civil Procedure 1042-28(b). (Please see Exhibits "1" and "2").

Counsel for Plaintiff immediately attempted to schedule the depositions of the Defendants in this matter, however, he received a letter dated April 27, 2004 from counsel for Defendant Jennifer Wineberg-Zeitler indicating that he was unavailable for deposition in May or June. Counsel for Plaintiff has a preplanned prepaid trip scheduled from July 21, 2004 through August 11, 2004 to China as part of his teaching work at Drexel University in Philadelphia and is unavailable for depositions during that time.

An effort was made to schedule depositions on August 18 and 19, 2004, however, counsel for Defendants DuBois Regional Medical Center, George Palmer, MD. and Russell E. Cameron, MD was unavailable.

Dr. Jennifer Wineberg-Zeitler has indicated that because of her professional responsibilities, she is only available on Wednesdays for deposition.

Because of the various scheduling conflicts, the depositions have still not been scheduled.

Plaintiff and counsel for Plaintiff recognize the importance of the work of the various Defendants and do not wish to compel them to appear for deposition at a time which might conflict with their professional obligations. Thus, Plaintiff files this Motion seeking to have the Court enter a Management Order which will accommodate the parties and assure that all parties will have their rights protected.

II-LEGAL ARGUMENT

On March 29, 2004, the Supreme Court of Pennsylvania promulgated a number of new rules pertaining to medical professional liability actions. Among the new rules is Rule 1042.28 which permits a Defendant to serve upon a Plaintiff a Request for Production of an Expert Report within 180 days after service:

(a) (1) A defendant against whom a claim of professional negligence has been made may serve on a plaintiff making that claim a Defendant's Request to Plaintiff for Production of Expert Reports. The request shall be substantially in the form prescribed by Rule 1042.36...

(b) A plaintiff to whom a request has been made under subdivision (a) shall, within one hundred eighty days after service of the request, furnish to the requesting party expert reports summarizing the expert testimony that will be offered by that plaintiff to support the claims of professional negligence made by that plaintiff against the requesting party.

Pennsylvania Rule of Civil Procedure 1042.31 provides that the Court may extend the time in which Plaintiff is required to provide a report if the Plaintiff is acting with "reasonable diligence":

(a) A party who has not received an expert report required to be produced under these rules may upon motion obtain a court order compelling the production of the report. In ruling on the motion, the court shall consider the complexity of the case, the diligence of the parties in making and responding to discovery requests, and other relevant factors. A party who has proceeded with reasonable diligence shall be given a reasonable time in which to complete necessary discovery and to produce an expert report.

In the case at bar, Plaintiff has attempted to act with due diligence as set forth above.

Within a few days of receiving Defendants' Requests for Production of the Expert Reports, counsel for Plaintiff began attempting to schedule the depositions of the various Defendants. Despite numerous telephone calls and considerable correspondence, those depositions have not been scheduled because of the calendars of the various Defendants and counsel. Under the circumstances, it would be reasonable for the court to extend the time for Plaintiff to provide the required expert report(s).

Pennsylvania Rule of Civil Procedure 1042.26 provides a mechanism under which the court can manage the cases under its jurisdiction. Pennsylvania Rule of Civil Procedure 1042.26 (b) provides:

(b) The rules of this chapter are applicable only in those jurisdictions where the court has not established case management deadlines by court order or otherwise.

Official Note: These rules do not apply if the court has set different times for the production of expert reports, whether those times are established before or after a party has initiated a proceeding under this chapter by filing of a request for expert reports.


Counsel for Plaintiff is continuing to attempt to schedule the depositions of the Defendants in this matter which are necessary in order to secured the required expert reports. It is respectfully suggested that the Court enter the attached Order which will require the Plaintiff to produce expert reports within 180 days of the deposition of the last of the named Defendants. By entering such an Order, the court will assure that the matter continues to move forward while allowing counsel to extend professional courtesies to each other and to

the parties. All counsel in this matter have busy trial schedules at are subject to frequent attachment for trial by the Courts. By allowing the flexibility provided in the proposed Order, discovery in this matter and the production of reports can proceed in an orderly but unforced fashion allowing counsel to attend to their trials and other professional obligations.

Because all of the rules cited herein were adopted on March 29, 2004, there is no legal authority which is binding upon the Court. It is respectfully requested that the Court exercise its discretion and grant the relief requested herein.
