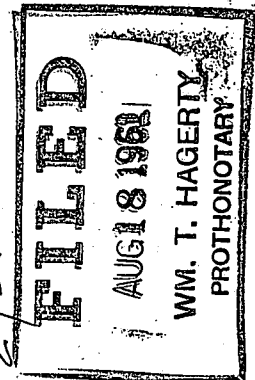

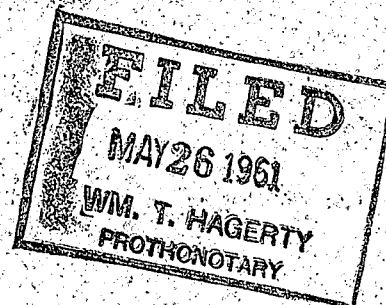

COMPLAINT

The Commonwealth of Pennsylvania, Department of Public Welfare, the plaintiff in the above-captioned case, claims of George Yontosh and Clara M. Yontosh, the defendants, the sum of \$1,832.97 (active), which is justly due and payable to the plaintiff by the defendants upon a cause of action whereof the following is a statement:

1. Pursuant to the Public Assistance Law of June 24, 1937, P. L. 2051, its supplements and amendments, the Commonwealth of Pennsylvania, through the Department of Public Welfare, from February 13, 1956 to January 28, 1961, inclusive, paid to Clara M. Yontosh for the support and maintenance of herself and minor children the sum of \$1,832.97 (active), at the times and in the amounts as shown in Exhibit "A" hereto annexed and made a part hereof, which assistance is still being paid to the beneficiaries as above set forth.

2. Under Section 4 of the Act of June 24, 1937, P. L. 2045, as amended, known as "The Support Law", the real and personal property of any person is liable for the expenses of his/her support, maintenance, assistance and burial, and for the expenses of the support, maintenance, assistance and burial of the spouse and minor children of such property owner, incurred by any public body or public agency, if such property was owned

during the time such expenses were incurred, or if a right or cause of action existed during the time such expenses were incurred from which the ownership of such property resulted.

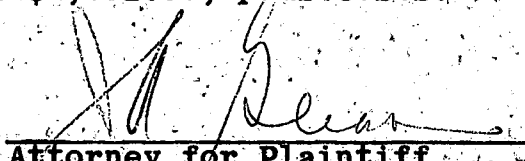
3. The said George Yontosh is the husband of the said Clara M. Yontosh for whom support was furnished as aforesaid.

4. Defendants were the owners of real property at the time the assistance was granted and paid.

5. The Plaintiff has demanded the sum of \$1,832.97 from the defendants, but the latter have failed and refused to pay the same or any part thereof to the plaintiff.

6. Defendant Clara M. Yontosh is a resident of Clearfield County, Pennsylvania, her address being Winburne, Pennsylvania. Defendant George Yontosh is a resident of Clearfield County, Pennsylvania, his address being Winburne, Pennsylvania, and owning an interest in real property situated in said County of Clearfield and Commonwealth of Pennsylvania.

WHEREFORE, the plaintiff demands judgment against the defendants for the said sum of \$1,832.97, plus costs.
