AND NOW, this 24 day of March, 2003, the Court having reviewed Petitioner's In Rem Action to establish title to One 1986 Chevrolet Corvette bearing VIN# 1G1YY0783G5111784, and the Court being satisfied that all reasonable efforts have been made to effectuate actual notice on any party having an interest in this vehicle, the Court hereby establishes the 12 day of May, 2003, at 9:00 o'clock A.m. in Court Room No. 1 of the Clearfield County Courthouse, Clearfield Pennsylvania, as the day, date and time for any party claiming an interest in this vehicle to appear and prove their claim of title to the vehicle. 

AND NOW, comes your Petitioner, Ronald Young, by and through his attorney, Christopher J. Shaw, Esquire, and moves this honorable Court to grant him title to a certain 1986 Chevrolet Corvette VIN# 1G1YY0783G5111784, following opportunity for anyone to contest the same after notice by publication service.

1. Petitioner is Ronald Young of Box 1218 Treasure Lake, DuBois Clearfield County Pennsylvania 15801.

2. Petitioner claims title to and since July 1988 has had uninterrupted physical possession of one 1986 Chevrolet Corvette bearing Vehicle Identification #1G1YY0783G5111784. This vehicle has, however, never been registered by Petitioner.

3. The last mention of record ownership of this vehicle is when this vehicle, then registered to Miller Leasing, Inc., P.O Box 190 Grand Haven Michigan, 49417 was involved in a one vehicle fatal accident on April 11, 1988, along Route 255 in DuBois, Clearfield County, Pennsylvania. A copy of the Police Accident Report is attached hereto as Exhibit "A".

4. This accident report indicates that although the vehicle was registered to Miller Leasing, Inc., the insurance was policy was through Auto Carrier Insurance Co. of Lansing Michigan. As noted on the Insurance declaration attached hereto as Exhibit "B", the insured on this policy was actually Earl Burlingame.

5. On April 11, 1988, this vehicle was being operated by one Charles A. Schalk, of 423 South Main Street, DuBois, Clearfield County, Pennsylvania. Mr. Schalk was killed in the accident.

6. A Passenger in the vehicle, one Earl E. Burlingame, Jr. of 249 Main Street, Falls Creek, Pennsylvania, was the reputed owner of the vehicle despite the fact that it was technically owned by Miller Leasing, Inc. Said Earl E. Burlingame, Jr., was charged with the criminal offense of permitting violation of title at Clearfield County No. 88-314-CR. Although Earl E. Burlingame, Jr. was acquitted of this offense due to insufficient evidence that said Earl E. Burlingame knew the operator was intoxicated, this criminal action still tends to prove the recognized "ownership" of this vehicle by Earl E. Burlingame, Jr. In addition, a civil suit involving the Estate of the decedent, Charles A. Schalk against Earl E. Burlingame, Jr. was filed in Clearfield County at No. 88-1892-CD. This also serves as proof that said Earl E. Burlingame was the owner of the vehicle in 1988.

7. Petitioner purchased this vehicle on July 7, 1988, four months after the fatal accident, from Chapman Auto Parts & Sales of R. D. #1, DuBois in an "as is" condition, the vehicle having been involved in the accident described previously. A copy of the agreement of sale is attached hereto as Exhibit "C".

8. At the time Petitioner purchased the vehicle, he was given a Title to the vehicle from the State of Michigan duly executed by Miller Leasing and/or Earl E. Burlingame, Jr. Petitioner, however, lost this title.

9. Petitioner later obtained a "lost title" from the Pennsylvania Department of Transportation, but this title was also lost.

10. Since Petitioner acquired title to this vehicle, he has never had it registered with the Pennsylvania Department of Transportation. However, upon Petitioner seeking to have the vehicle registered, Petitioner learned that all records of this vehicle with the Pennsylvania Department of Transportation have been purged due to the fact that the vehicle has not been registered for more than 10 years. Therefore, Petitioner cannot obtain another lost title.

11. Petitioner has also caused a search of the motor vehicle records to be conducted in Michigan, and there is no record of ownership found in Michigan either. A copy of the report from the Michigan Department of Motor Vehicles is attached hereto as Exhibit "D".

12. Earl E. Burlingame died on May 25, 1992. An Estate was opened for this individual in the Court of Common Pleas of Clearfield County at No. 19-92-195 wherein an individual named Carole G. Armstrong was appointed as Administratrix. This is the same individual who executed an affidavit when Petitioner attempted to get a "lost title" on this vehicle. At that time, this individual, on behalf of Earl E. Burlingame, Jr., disavowed any interest in the vehicle knowing that Petitioner, Ronald Young, was the rightful owner.

13. The attorney for the Estate of Earl Burlingame, Gregory Kruk, has advised the attorney for Petitioner that he is unable to locate either the administratrix of the estate or the sole beneficiary, Brian Burlingame. For this reason, the Estate of Earl E. Burlingame, Jr. remains open with little hope of resolution.

14. Petitioner has verified through the Pennsylvania State Police that the VIN # is a valid VIN # for a 1986 Chevrolet Corvette and that this vehicle is not listed as stolen.

15. Petitioner has contacted both the insurer of the vehicle at the time of the accident, who has no records of this vehicle or its owner, and with the car dealership that originally sold the car to "reconstruct" the title but no entity which could be expected to have any documentation about this vehicle continues to have any of this documentation.

16. Petitioner believes, and therefore avers that the only person other than petitioner who ever had an ownership interest in this vehicle would be Miller Leasing and/or Earl E. Burlingame, Jr. and now his estate. The attorney for the Estate of Earl E. Burlingame has been notified of this Petition, and has claimed no ownership interest in this vehicle. Further notice of this action will be given by publication if approved by this Honorable Court.

WHEREFORE, Petitioner respectfully requests that this Honorable Court order that the filing of this petition be served by Publication and that if no answer is filed thereto, that the Court enter an Order declaring that Petitioner, Ronald Young is the rightful owner of this 1988 Chevrolet Corvette.





THIS OFFICER OBSERVED UNIT #1 TRAVELLING NORTH ON SR 255 AT DIVISION ST APPROX 1/10 OF A MILE SOUTH OF THE ACCIDENT SITE AT A HIGH RATE OF SPEED (APPROX 85 MPH) THIS OFFICER ARRIVED ON SCENE APPROX 30 SECONDS LATER. SUBJECTS THAT HAD SEEN THE OCCUPANTS AND TALKED TO THEM JUST PRIOR TO THE ACCIDENT STATED THAT THE DECEASED WAS OPERATING THE VEHICLE AT THAT TIME.
