ORDINANCE NO. 2003-07

AN ORDINANCE PROVIDING FOR THE VACATION OF AN UNKNOWN SIXTEEN (16) FOOT ALLEY BETWEEN MILL ROAD AND SR-0322/SR-0153, LAWRENCE TOWNSHIP, CLEARFIELD COUNTY, PENNSYLVANIA.

WHEREAS, Lawrence Township Fire Company No. 1 has petitioned the Lawrence Township Supervisors to vacate an unknown sixteen (16) foot alley between Mill Road and SR-0322/SR-0153; and

WHEREAS, the Lawrence Township Supervisors have given public notice and notice to the owners adjacent to the unknown alley ten (10) days in advance of the hearing that was held on March 18, 2003 at 2:15 p.m. to inquire into the merits of vacating the unknown alley;

AND WHEREAS, the hearing was held and no one appeared to object to said action.

NOW THEREFORE BE IT ORDAINED:

1. That an unknown sixteen (16) foot alley between Mill Road and SR-0322/SR-0153 be and it is hereby vacated and closed and removed from the Township road system.

2. The Lawrence Township Secretary is directed to record this Ordinance together with the attached draft of the alley being vacated in the Prothonotary's Office of the Court of Common Pleas, of Clearfield County.
