and by virtue of any exemption law now in force or which may be hereafter passed.

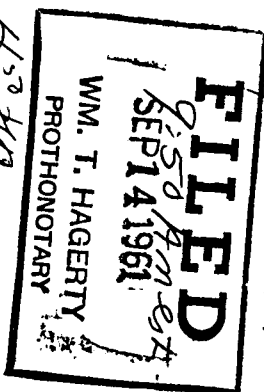
