



WE, JEFFERY WAYNE PORTER and CHRISTINE HARRINGTON PORTER, of 5800 Donson Way, Pittsburgh, Pennsylvania 15201, do hereby promise to pay to **THE CLEARFIELD FOUNDATION**, a Pennsylvania corporation with an office and place of business at 125 East Market Street, Clearfield, Pennsylvania 16830, the sum of **Twenty-Five Thousand Dollars and no/100 (\$25,000.00)**, payable over five (5) years at the rate of **Five Per Cent (5%)** per annum, payable as follows:

(a) **Five Thousand Dollars and no/100 (\$5,000.00)**, together with accrued interest shall be paid on or before August 12, 2003, provided this Note shall not be in default so long as payment is made within five (5) days of that date;

AND FURTHER, we do hereby reserve the right to prepay, in whole or part, the principal and interest due on this Note without penalty.



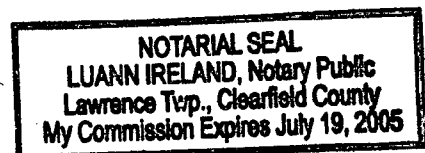
