COMPLAINT

1. Plaintiff is Shelly Reed, t/d/b/a Wallaceton Hardwoods, having its principal place of business at Reed Street, Wallaceton, Pennsylvania 16876.

2. Defendant is Gary G. Ramm an individual residing at 235 Polecat Road, Landisburg, Pennsylvania 17040.

3. On or about February 26, 2002, Plaintiff entered into an agreement with the Defendant for him to purchase certain timber to be delivered to Wallaceton Hardwoods within 30 to 60 days.

4. In furtherance of this purpose, Plaintiff advanced to Defendant, the sum of Forty-five Thousand Dollars (\$45,000.00) to be used to purchase said timber.

5. After receiving the Forty-five Thousand Dollars (\$45,000.00), Defendant then delivered to Plaintiff, logs having a value of Twenty-five Thousand Eight Hundred Sixteen Dollars and Eighty Cents (\$25,816.80) which was credited against the Forty-five


Thousand Dollars (\$45,000.00) advance, leaving an amount owing to Plaintiff of Nineteen Thousand One Hundred Eighty-three Dollars and Twenty Cents (\$19,183.20).

6. As of the date of filing this Complaint, Defendant has failed to deliver additional timber sufficient to cover the balance of the cash advance.

7. Plaintiff has made demand upon Defendant to return the balance of their funds, being Nineteen Thousand One Hundred Eighty-three Dollars and Twenty Cents (\$19,183.20).

8. Defendant has refused to do so even after demand has been made upon him.

WHEREFORE, Plaintiff demands judgment against Defendant in the amount of Nineteen Thousand One Hundred Eighty-three Dollars and Twenty Cents (\$19,183.20), plus interest from February 26, 2002, to date.


