DECLARATION OF TAKING

The CITY OF DUBOIS, pursuant to the Pennsylvania Eminent Domain Code, as amended, 26 Pa. Stat. Ann. §1-101, *et seq.* ("Code"), hereby declares:

1. The Condemnor is the CITY OF DUBOIS, whose address is 16 West Scribner Avenue, DuBois, Pennsylvania 15801.
2. This condemnation is authorized by 53 P.S. §37801 empowering Third Class Cities to exercise eminent domain for the construction, erection and extension of sewers, public works, filtration plants, sewage systems, sewage treatment works and other such projects.
3. Pursuant to Ordinance No. 1656, enacted October 28, 2002, the CITY OF DUBOIS hereby appropriates and condemns real estate designated in the Ordinance, a true and correct copy of which is attached as Exhibit "A".
4. The name of the Condemnee is BUFFALO & PITTSBURGH RAILROAD, INC., whose last known address is 1200-C Scottsville Road, Suite 200, Rochester, New York 14624.

5. The property has been condemned by the CITY OF DUBOIS for purposes of the construction of flow equalization facilities to eliminate unauthorized bypasses of sewage at the head of the sewage treatment plant operated by the CITY OF DUBOIS, as provided for by the Ordinance.

6. The title acquired by the CITY OF DUBOIS shall be fee simple title.

7. A plan of the property condemned is being lodged for record in the Offices of the Register and Recorder of Deeds of Clearfield County, Pennsylvania, as of the same date as the filing of this Declaration of Taking, in accordance with Section 404 of the Code, 26 Pa. Stat. Ann. §1-404. A copy of the plan is attached hereto as Exhibit "B".

8. Both the ordinance and the plan may be inspected at the address of the Condemnor, the CITY OF DUBOIS.

9. Under Section 403(b) of the Code, 26 Pa. Stat. Ann. §1-403(b), the power of taxation granted to the CITY OF DUBOIS by the State Legislature of the Commonwealth of Pennsylvania is sufficient to secure just compensation for the appropriation of the property described herein.

10. Pursuant to Section 405(d) of the Code, 26 Pa. Stat. Ann. §1-405(d), a conformed copy of this declaration of taking, together with the information and notice required by Section 405(c) thereof, 26 Pa. Stat. Ann. §1-405(c), will be served upon the Condemnee in this proceeding. Proof of such service will be filed.





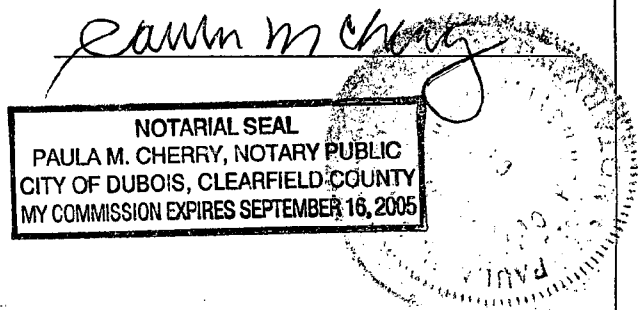

AN ORDINANCE

AUTHORIZING CHESTER ENGINEERS, THE CONSULTING ENGINEERS HIRED BY THE CITY OF DUBOIS TO SELECT AND APPROPRIATE CERTAIN PLOTS OF GROUND WITH THE IMPROVEMENTS THEREON SITUATED FOR PURPOSES OF THE CONSTRUCTION OF FLOW EQUALIZATION FACILITIES TO ELIMINATE UNAUTHORIZED BYPASSES OF SEWAGE AT THE HEAD OF THE SEWAGE TREATMENT PLANT OPERATED BY THE CITY OF DUBOIS FOR THE HEALTH AND SAFETY OF ITS CITIZENS AND CUSTOMERS AND FOR FUTURE EXPANSION.

The Council of the City of DuBois hereby ordains:

Section 1. Chester Engineers, the consulting engineers hired by the City of DuBois, are hereby authorized to select and appropriate the following plots of ground for the purposes of the construction of flow equalization facilities to eliminate unauthorized bypasses of sewage at the head of the sewage treatment plant operated by the City of DuBois for the health and safety of its citizens and customers and for future expansion:

ALL that certain piece or tract of land situate, lying and being in the Township of Sandy, Clearfield County, Pennsylvania, and being bounded and described as follows, to wit:

Beginning at a point in the northerly line of lands now or formerly owned by William Reed and Donna J. Reed where said line is intersected by the westerly line of lands now or formerly owned by the City of DuBois; thence North 75° 44' West, a distance of 181.65 feet to a point on the easterly line of lands owned by the City of DuBois; thence North 19° 01' East a distance of 287 feet more or less to a point; thence South 55° 42' 20" East, a distance of 89 feet more or less to a point at the corner of lands now or formerly owned by the City of DuBois; thence by a curve to the left with a radius of 445.3 feet and along the western line of lands now or formerly owned by the City of DuBois, a distance of 270.53 feet to the place of beginning. CONTAINING 0.73 acres more or less.

BEING a portion of the same premises which were conveyed to Buffalo & Pittsburgh Railroad, Inc., a Delaware Corporation, by deed of CSX Transportation, Inc., a Virginia Corporation, and the Buffalo, Rochester and Pittsburgh Railway Company, dated October 7, 1991, and recorded in the Offices of the Register and Recorder of Deeds of Clearfield County, Pennsylvania, in Deed Book Vol. 1432, page 285.


Section 2. The Solicitor of the City of DuBois is authorized and directed to prepare and file with the Court of Common Pleas of Clearfield County, Pennsylvania, a declaration of taking which shall be executed by the Mayor of the City of DuBois and to take any action that may be necessary or desirable to carry out the intent and purposes of this Ordinance.


