STIPULATION AGAINST LIENS





This stipulation is made and intended to be filed with the County Prothonotary within ten (10) days after date, in accordance with the requirements of Act of Assembly of Pennsylvania, in such case provided.

MADE THE 8th Day of June 1909 in the year of our Lord one thousand nine hundred seventy-six (1976)

BETWEEN GLADYS E. BECK and JOHN BECK, her husband, of 1025 South Brody Street, DuBois, Pa.; WILLIAM H. COWIE, JR., and PHYLLIS COWIE, his wife, of 1025 South Brody Street, DuBois, Pa.; LEOTA M. GEARHART and HOMER GEARHART, her husband, of R. D. 1, DuBois, Pa.; DONNA JEAN GETTO and CHARLES GETTO, her husband, of Lawrence Park, Erie, Pa.; DIANE LYNN FURL and DENNIS FURL, her husband, of R. D. 1, Brookville, Pa.; VIOLET MCKEE and CARL MCKEE, her husband, of Don Street, DuBois, Pa.; WILLIAM W. RAFFERTY, single, of DuBois, Pa.;

and WILLIAM H. COWIE, JR., and PHYLLIS COWIE, his wife, of 1025 South Brody Street, DuBois, Clearfield County, Pennsylvania, as tenants by the entireties with the right of survivorship and not as tenants in common,

WITNESSETH: that in consideration of ONE and no/100ths (\$1.00) -----

in hand paid, the receipt whereof is hereby acknowledged, the said grantors do hereby grant and convey to the said grantees, their heirs and assigns,

ALL of their right, title and interest in the property located in Sandy Township, Clearfield County, Pennsylvania, being known on the Plan of Loeb Bros. Addition No. 4 to DuBois, which said plot is recorded at Clearfield, Pennsylvania, in Miscellaneous Book 9, Page 489, as Lots Nos. 13 and 14, bounded and described as follows, to-wit:

LOT No. 13 bounded on the North by Lot No. 12; on the East by Walnut Street; on the South by Lot No. 14 and on the West by lands of Loeb Bros. Being a lot of ground 25' x 100'. And being the same premises which Norman Loeb and others, by Deed dated January 27, 1919, and recorded in Deed Book 231, Page 170, granted and conveyed to William H. Cowie.

LOT No. 14, bounded on the North by Lot No. 13; on the East by Walnut Street; on the South by Lot No. 15 and on the West by lands of Loeb Bros. Being a lot of ground 25' x 100'. And being the same premises which Charles S. Cowie and Lotie Cowie, his wife, by Deed dated November 15, 1923, and recorded in Deed Book 267, Page 216, granted and conveyed to William H. Cowie.
