COMPLAINT IN EQUITY

AND NOW COMES Plaintiff, EOG Resources Appalachian, LLC, by and through its attorney, Michael S. Delaney, Esquire, and files the following Petition for Preliminary Injunction, and in support thereof avers as follows:

The Parties

1. Plaintiff, EOG Resources Appalachian, LLC ("EOG"), is a corporation organized and existing under the laws of the State of Delaware, with its principal place of business at 400 Southpointe Boulevard, Suite 300, Canonsburg, Pennsylvania, 15317.

2. The Defendants, John F. Weber and Alvria J. Weber, his wife, are individuals residing at 344 East Main Street, Sykesville, Pennsylvania, 15865.

3. The Respondent, Mike Weber, Sr., is an individual residing at South Park Street Extension, Sykesville, Pennsylvania, 15865.

4. The Respondent, John Weber, Jr., is an individual residing at 1191 South Main Street, DuBois, Pennsylvania, 15081.

5. The Respondent, James Weber, is an individual residing at Newport News, Virginia, in care of John F. Weber, 344 East Main Street, Sykesville, Pennsylvania, 15865.

6. The Respondent, Dan Weber, is an individual residing at Chicago, Illinois, in care of John F. Weber, 344 East Main Street, Sykesville, Pennsylvania, 15865.

Plaintiff's Rights

7. The Defendants are the owners of 83 acres of surface, situate in Bell Township, Clearfield County, Pennsylvania, KNOWN as Clearfield County Assessment Parcel Number 102-B08-1, as depicted on the partial copy of the Clearfield County Assessment Map attached hereto and marked Exhibit "A" (the "subject tract").

8. EOG is the fee owner of the oil and gas estate underlying the subject tract, as well as underlying the adjoining tract of land, known as Clearfield County Assessment Parcel Number 102-B08-35, the surface of which is owned by Willis Cunkelman and Jacqueline Cunkelman, his wife (the "adjoining tract").

9. Pursuant to its ownership in fee of oil and gas, EOG has, among other rights and privileges, the right to explore, test, drill, construct and maintain pipelines, equipment, structures, and to produce and operate for oil and gas underlying the subject tract and the adjoining tract.

10. Pursuant to EOG's fee ownership of the oil and gas, EOG acquired from the Commonwealth of Pennsylvania, Department of Environmental Protection, Oil and Gas Management Program, a Natural Gas Well Permit, Permit No. 24556, for the purpose of drilling and operating upon its oil and gas estate a natural gas well situate upon the adjoining tract as more fully depicted on the Well Location Plat attached hereto and marked Exhibit "B" (the "subject well").

Defendants' Improper Actions

11. Within the last thirty(30) days, John F. Weber, acting on behalf of himself and as co-tenant of Defendants, has unreasonably withheld consent and continues to refuse EOG access to the subject tract of land for the purpose of constructing a well site on the subject tract of land and adjoining tract of land which is necessary for the drilling of the subject well.

Plaintiff's Right to a Preliminary Injunction

12. EOG has made a substantial investment in the drilling of a natural gas well upon the adjoining tract of land.

13. As indicated above, Defendants have unreasonably withheld their consent, refuses and continues to refuse EOG access to the subject tract of land for the purpose of constructing a well site location and generally operating and maintaining an oil and gas well, oil and gas pipeline and associated production equipment for the purpose of producing and transporting the natural gas to market.

14. If Defendants are not enjoined from their illegal and improper actions as described above, such conduct will deprive EOG of substantial rights which it possesses that are not redressable by damages.

15. Moreover, if Defendants are not enjoined from their illegal and improper conduct as set forth above, such action will result in the wasting and diminution of valuable assets of EOG and will cause EOG substantial damage which will be difficult, if not impossible, to ascertain. Such damages may include, but are not limited to, damage to the overall business plan of EOG and loss of proceeds from the sale of oil and gas from the oil and gas well to be drilled upon the adjoining tract of land.

16. If Respondent is not enjoined from their improper conduct as set forth above, the status quo will not be preserved. To the contrary, an injunction barring Defendants' improper conduct will preserve the status quo by returning the parties to the situation existing just prior to Respondent's commencement of such conduct.

17. The Plaintiff, EOG, does not have an adequate remedy at law to address the impending harm from the threatened conduct of Defendants, as the damages to the Plaintiff and Plaintiff's rights cannot be adequately measured in damages.

18. Defendants will not suffer any appreciable injury if they are enjoined from their illegal and improper actions as set forth above, because the subject tract of land owned by Defendants is servient to the oil and gas estate owned by Plaintiff.

WHEREFORE, EOG respectfully requests that this Court enter an Order:

(A) granting a preliminary injunction against Defendants, together with their agents, servants, contractors, representatives and family members, from denying Plaintiff access to the subject tract for the purpose of constructing, operating and maintaining an oil and gas well, oil and gas pipelines, and associated production equipment for the purpose of producing and transporting the gas to market;

(B) awarding the Plaintiff its costs and expenses incurred in pursuing this matter; and

(C) granting such other and further relief as the Court deems just and proper.
