1. Plaintiff William G. Satterlee & Sons, Inc. is a Pennsylvania corporation with an office and place of business at R.D. #1, Box 173, Rochester Mills, PA 15771 ("**Satterlee**").

2. Defendant Kenneth W. Welder is an individual with a mailing address of 84 High Street, Woodland, Pennsylvania 16881 ("**Welder**").

3. That Welder purchased from Satterlee diesel fuel and related products commencing on August 31, 2002 through February 28, 2003.

4. That Satterlee charged Welder its usual and customary charges for said diesel fuel and related products.

5. That during the time of Welder purchases, Satterlee maintained books of account, keeping an accurate and running

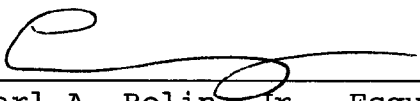
account of all debits and credits for the sale of diesel fuel and related products to Welder.

6. That Satterlee submitted to Welder a written account monthly requesting payment for the outstanding balance on the account. A copy of said accounting is attached hereto and marked Exhibit "A."

7. That Satterlee has made a demand for the payment of said outstanding balances due on said account which Welder has failed and refused to pay.

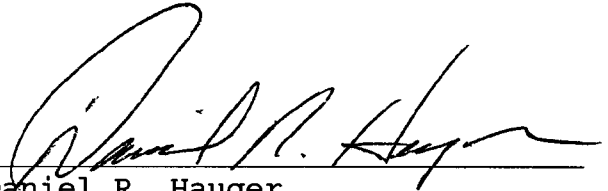
