COMPLAINT - CIVIL ACTION

AND NOW, comes Plaintiff, MICHELLE WILSON, by and through her attorney, David B. Inzana, Esquire, and files the within Complaint, and in support thereof avers the following:

1) Plaintiff Michelle Wilson, an adult individual who at all times relevant to this complaint resided at RD#3 Box 60, DuBois, Clearfield County, PA 15801.

2) Defendant, Sandhya Seth, is an adult individual who at all times relevant to this complaint resided at 5 Breezewood Ave., DuBois, PA 15801.

3) The facts and occurrences hereinafter stated took place on 30th day of June, 2001 at approximately 1:56 p.m. in the City of DuBois, County of Clearfield, Commonwealth of Pennsylvania.

4) At the aforesaid time, date and place, Plaintiff was operating a motor vehicle that was traveling west on Maple Ave. near the intersection of 6th S. Street in the City of DuBois, Pennsylvania.

5) At the aforesaid time, date and place, Defendant did operate his motor vehicle in a Northerly direction on S. Sixth Street and failed to obey the stop sign at the intersection of S. Sixth and Maple. Defendant did operate his vehicle in such a negligent, careless and reckless manner so as to cause his vehicle to make contact with the motor vehicle driven by plaintiff.

6) As a result of the aforesaid negligence, carelessness and recklessness of the Defendant, Plaintiff did sustain the injuries as follows:

- (a) Pain and injuries accosiated with whiplash
- (b) Jaw injuries
- (c) Stress fractures on the kneecap

7) The injuries of the Plaintiff were the direct legal and proximate cause of the negligence, carelessness and recklessness of the Defendant which consists of the following:

- (a) Failure to abide by the Pennsylvania Vehicle Code by Running a Stop Sign;
- (b) Failing to apply the brakes of his motor vehicle at a time to avoid a collision with Plaintiff;
- (c) Negligently and carelessly applying the brakes;
- (d) Failing to observe the Plaintiff's vehicle on the highway;


8) The injuries to the Plaintiff and the damages suffered by the Plaintiff were caused solely and exclusively by the negligence, carelessness and recklessness of the Defendant, and were in no way caused by the Plaintiff. Solely as a result of the aforementioned accident, Plaintiff has been caused to sustain serious physical injuries, the full extent of which are presently unknown. To date, Plaintiff has had extensive injuries to her jaw and has had to undergo two (2) surgeries thus far. It is expected that at least one more surgical procedure will be probable.

9) As a result of the injuries sustained by the plaintiffs herein, plaintiff has undergone in the past and will in the future undergo pain and suffering.

10) As a result of the injuries sustained by the Plaintiff herein, the Plaintiff has suffered a permanent diminution in the ability to enjoy her life and life's pleasures.

WHEREFORE, Plaintiff hereby demands judgment against defendants in an amount in excess of Twenty Five Thousand (\$25,000.00) Dollars, plus interests, costs, and any damages for delay.

**EMERGENCY MOTION TO STRIKE ECONOMIC EXPERT/
MOTION FOR SANCTIONS**

AND NOW, comes the Defendant, Sandhya Seth, by and through the undersigned Counsel, Laura R. Signorelli, Esquire, hereby respectfully moves this Honorable Court to enter an Order Striking Plaintiff's Economic Expert in this matter and Assessing Sanctions and respectfully states:

1. This motion is being presented as an Emergency Motion, as the case is listed for a date certain Jury trial in front of the Honorable Paul Cherry on October 30, 2007. Jury selection was completed on August 28, 2007 and the jurors were empanelled on this date.

2. On October 2, 2007, twenty-eight (28) days prior to trial, Plaintiff's counsel, for the first time, disclosed to Defense counsel an economic expert report via supplemental pretrial statement (**A true and correct copy of the supplemental pretrial statement is attached hereto and marked as Exhibit A**) In that report, Plaintiff is asserting a claim for an alleged loss of profits from a daycare business and impairment of earning capacity.

3. The economic loss expert, first disclosed less than 30 days prior to trial, i.e. Donal Kirwin, was not disclosed at the time of the pretrial conference on August 24, 2007.

4. Previously, on March 28, 2007, a Certificate of Readiness had been filed by Plaintiff's counsel regarding this matter.

5 Pursuant to Clearfield Local Rule of Civil Procedure 212.4 and Order by this Honorable Court, all pretrial statements by the parties are due one week before the date set for the Pretrial Conference. In that Pretrial statement, the parties are required to set forth:

(3) A list of names and addresses of all persons who may be called as witnesses, classifying them as liability and/or damages witnesses. . . . and

(5) the reports of any expert whose opinion will be offered in evidence at time of trial. Such report shall include the findings and conclusions of the expert.

. . .

(6) A list of all items of special damages which the party intends to prove, including If the party is self-employed, information which forms the basis for the loss of income attributable to the injuries shall be supplied.

Pa. Local Rule of Civil Procedure, Clearfield County 212.4

6. Local Rule of Clearfield County 212.4 states that a party is precluded from calling an expert which has not been disclosed prior to the pre-trial conference:

Once a pretrial conference has been held, a party shall not have the right to call any witness where the witness was not listed in the pre-trial statement, to call an expert witness where the report was not appended to the pre-trial statement
...

Pa. Local Rule of Civil Procedure, Clearfield County 212.4 (f)

7. Pa.R.C.P. 212.2(a) also requires that the pre-trial statement shall disclose :

(a)(3) a list of the names and addresses of all persons who may be called as witnesses by the party filing the statement classifying them as liability or damage witnesses. . . .

(a)(5) a copy of the written report or answer to written interrogatory consistent with Rule 4003.5, containing the opinion and the basis for the opinion of any person who may be called as an expert witness;

I. MOTION TO STRIKE EXPERT ECONOMIST

8. Pursuant to Pa.R.C.P. 212.2 (C), “. . . where the trial judge determines that unfair prejudice shall occur as a result of non-compliance with subdivisions (a) and (b) of Pa.R.C.P. 212.2, the trial judge shall grant appropriate relief which may include:

(1) the preclusion or limitation of the testimony of:

(i) any witness whose identity is not disclosed in the pre-trial statement, or

(ii) any expert witness whose opinions have not been set forth in the report submitted with the pre-trial statement or otherwise specifically referred to in the pre-trial statement, consistent with Rule 4003.5, and

(2) the preclusion of exhibits not listed in the pre-trial statement and made available.

Pa.R.C.P. 212.2(c) (1) and (2)

9. Defendant is being severely and continuously prejudiced by the inability to properly retain a qualified expert to review the bases for the Plaintiff's expert's opinions as well as to prepare a rebuttal.

10.. Additionally, on August 28, 2007 a jury panel of 12 was selected in this matter through voir dire questioning of the potential jurors in open court. At no time prior to this jury selection did Plaintiff disclose their economic expert.

11. Defendant is additionally severely prejudiced by Plaintiff's late disclosure of the name of the economic loss expert, which precludes Defendant's ability to conduct a fair and complete voir dire examination prior to selection of the jury panel.

12. On November 14, 2003, Defendant through her counsel, propounded on Plaintiff, a list of interrogatories and request for production of documents which addressed experts intended to be called upon at trial. These requests were ongoing in nature. Specifically, Defendant requested:

21. Please state the name and present address of each person Plaintiff may call or expects to call as an expert witness at the trial of the case.

22. As to each person names in answer to Interrogatory Number 21, please state:

(a) the substance of fact to which he or she is expected to testify;

(b) the substance of each opinion to which he or she is expected to testify;

(c) the ground for each opinion; and

(d) their background, training, experience and other qualifications.

23. Except for those persons identified in Answer to Interrogatory Number 22, please state the name and present address of any person who has retained, employed or consulted by plaintiff as an expert in connection with the claim in this case or any defense to the claim in this case.

13. To date, and despite numerous request from defense counsel, Plaintiff, through her counsel has failed to produce any expert medical report supporting permanent disability

and/or impairment and the only report relied upon by Plaintiff's expert economist that the Plaintiff has a chronic cervical strain.

14. The Plaintiff's non-compliance with both state and local rules of civil procedure concerning disclosure of experts has severely prejudiced Defendant's ability to prepare a defense to the case in front of the jury already empaneled, and with such prejudice being un-correctable, Defendant specifically request of this Honorable Court the relief prescribed in the rules by way of striking of Plaintiff's expert.

WHEREFORE, Defendant respectfully requests this Honorable Court to enter an Order striking the Plaintiff's economic expert and precluding any testimony concerning any claim of loss of profits/earnings and/or impairment of earning capacity.

II. MOTION FOR ATTORNEY'S FEES

1. By engaging in a deliberate and willful course of conduct in deliberate disregard of the Rules of Civil Procedure governing disclosure of witnesses and pre-trial conferences, Plaintiff has severely prejudiced the Defendant's ability to prepare an appropriate defense of this case.

2. By attempting to limit the time by which Defendant can prepare a defense on this matter, Plaintiff is engaging in an course of conduct intended to harass the defendant, sabotage the ability to prepare an appropriate defense and to injure the Defendant with respect to limiting the Defendant's ability to defend the case.

3. As further evidence of Plaintiff's intentional actions to attempt to injure the defendant in this case, Plaintiff's counsel has refused the requests of Defense counsel to schedule

4 expert depositions on the same day(s) to avoid four (4) three-hundred mile trips to the Clearfield area on four separate occasions for medical depositions. Despite requests by Defense counsel, Plaintiff's counsel has scheduled one of the expert depositions for the day before the scheduled date of trial, i.e. October 29, 2007.

4.. Defendant will continue to suffer ramifications from Plaintiff's failure to comply with the Order of this Honorable Court, the local and state rules of Civil Procedure, in that Defendant will expend round-trip travel of 300 miles distance in making a trip to Court to present this motion.


5. Defendant has also lost approximately one-half day (4 hours) in being involved in the preparation of this within motion.

6 .Plaintiff is also in violation of Pa.R.C.P. 4003.5 concerning Plaintiff's failure to disclose the economic expert and supporting report until after the pretrial conciliation was conducted and discovery was closed.

7.By certifying that the case was ready for trial without having yet secured the economic expert report, Plaintiff is in violation of Pa.R.C.P. 1023.1 concerning disclosure to the Court.

8.Pursuant to Pa.R.C.P. 1023.2, this Honorable Court may enter an Order awarding reasonable attorney's fees to any party that is required to present a motion for relief due to the opposing party's certification made in violation of the rules and/or failure to comply with the rules of civil procedure.

WHEREFORE, Defendant respectfully requests this Honorable Court to enter an Order awarding reasonable costs and attorney's fees for presentation of the within motion.



Dear Ms. Painter:

You asked that I evaluate the economic loss in the case of your client, Michelle Wilson. You asked that I become familiar with your client's background and current circumstances in order to provide an opinion as to the labor economic effects of a motor vehicle accident that occurred on June 30, 2001. I interviewed Ms. Wilson and reviewed her educational background and work history. I also reviewed the following documents:

- Plaintiff's Complaint in Civil Action;
- Plaintiff's Answers to Defendant's Interrogatories;
- Plaintiff's Pretrial Statement with Plaintiff's Expert Reports;
- Copy of the transcript of the deposition of Michelle Wilson conducted January 10, 2006; and,
- Ms. Wilson's Schedule C's for the years 2003 – 2005.

Michelle Wilson was born March 12, 1966 and is currently 41.54 years old. She graduated from DuBois Area High School in 1984. She attended a cosmetology school but never obtained her license. She moved to Kansas and returned to Pennsylvania in 1993 after which she worked part-time for a caterer. On June 10, 2001, she opened a day care operation in her home. She was involved in the motor vehicle accident on June 30, 2001.

Ms. Wilson's medical history is detailed in Dr. Hennessey's Initial Outpatient Physiatriic Evaluation report of 5/30/2007 and will not be repeated here. His report indicates that she had residual post-traumatic cervical strain as a result of the 6/30/2001 motor vehicle accident but cannot recommend further treatment. He does say that the "residual cervical sprain is felt to be permanent." He also identifies idiopathic low back pain and bilateral persistent jaw pain. Jeffrey W. Rice, DMD, states on April 13, 2007, that "I am continually working to make Michelle more comfortable, but I don't feel she will ever be pain free." Ms. Wilson has undergone two dental surgeries (2/21/2002 and 4/1/2003) and back surgery on March 2, 2006.

Ms. Wilson is concerned about the impact her physical restrictions will have upon her ability to earn a living. She had opened her daycare operation approximately two weeks before the accident and was just beginning to develop the business. She initially cared for three children and, over time, increased that number to six. She stated that she was unable to physically care for the children from December 26, 2005 through August 31, 2006 at which time she reopened her

daycare. At that time, she only had 2 children to care for. She stated that she continued to operate in that fashion until June 1, 2007 at which time she closed the business.

Economic Damages

Past Lost Income: Ms. Wilson stated that she charged \$75 per child per week. At a maximum of 6 children, she would generate \$450 per week in gross revenues. Her Schedule C's show that she spent an average of 25% on expenses, therefore, her net weekly income would be \$337.50, **\$17,550** per year. Unable to operate for the period December 26, 2005 – August 31, 2006, she lost **\$16,200** in net income at that time. She stated that when she reopened September 1, 2006, she accepted 2 children from 1 family and that she offered a special rate of \$200 every two weeks. Operating in that fashion until June 1, 2007, her net income loss was **\$10,238**. In the period June 1, 2007 to September 21, 2007, she lost **\$5,400** in net income. Her total past lost net income is **\$27,788**.

Future Lost Earning Capacity: as an active participant in the labor market, Ms. Wilson, 35.3 years old at the time of the motor vehicle accident and a female high school graduate, has a tabular worklife expectancy of 20.31 years.¹ Since she is currently considered inactive, in that she is not working due to her injuries, her tabular worklife expectancy is reduced to 17.67 years, an erosion of 14.9%. The inactive classification assumes that at some point, Ms. Wilson would be able to return to the workforce but would not be able to work as many years. It has been 6.24 years since the motor vehicle accident, therefore her remaining tabular worklife expectancies are 14.07 and 11.43 respectively.

Three scenarios are presented regarding Ms. Wilson's future lost earning capacity: In scenario 1, it is assumed that she would have operated her daycare business to her remaining tabular worklife expectancy of 14.07 years. The net income for that period is compared to the net income she would earn over the reduced worklife expectancy of 11.43 years. In scenario 2, it is assumed that, if uninjured, she would operate her daycare business to age 60, a period of 18.46 years. Again, the net income for that period is compared to the net income earned over the shorter period. Ms. Wilson stated that her neighbor from whom she purchased the daycare business had operated it for forty (40) years. In scenario 3, I assumed that, due to her physical restrictions, she would not be able to return at all to the daycare business and showed her future lost earning capacity to her tabular worklife expectancy.

In scenario 1, she would have net income of \$246,929 over 14.07 years but only \$163,529 earned over 11.43 years, a lost earning capacity of **\$83,399**.

In scenario 2, she would have net income of \$323,973 working to age 60, but only \$163,529 over the 11.43 year reduced worklife expectancy, a lost earning capacity of **\$160,444**.

In scenario 3, were she physically unable to work, her future lost earning capacity for her worklife expectancy would be **\$246,929**.
